### Al-Qaeda escapee Mojali surrenders to security

SANA'A, April 3 — One of the Al-Qaeda members who escaped from Political Security Prison Feb. 3 surrendered to police last week. According to the Defense Ministry's 26 September Net website, Hizam Saleh Mojali is considered the sixth fugitive to surrender to security so far, from among 23 fugitives who dug out of the Sana'a intelligence jail.

Mojali was sentenced to death by the Competent Penal Court's appeals division for his link to the Al-Qaeda terrorist organization, participating with Jamal Badawi in the 2002 attack on French supertanker Limburg and for killing policeman Hameed Khasroof. This is the first time the government has announced the identity of an arrested prisoner, as the identities of five previously arrested prisoners remain unknown.

Media reported differing stories about the way the prisoners were arrested. According to local press, the last two surrendered in the southeastern province of Hadramout, telling police officials they decided to surrender after "finding it difficult to stay on the run any longer with police pursuing

them." Whereas Agence France-Presse (AFP), quoting a security official on condition of anonymity, reported in February that two escapees were arrested with the help of three other recently surrendered jail breakers. The men, who hail from the southeastern province of Al-Beidha, were arrested in Sana'a disguised in civilian clothing.

Immediately after the 23 prisoners' escape, Yemeni security forces set up checkpoints throughout Sana'a to try to catch them before they attempted hiding in mountainous tribal territories far from Yemeni government control. Security arrested approximately 200 of the fugitives' relatives and associates for investigation. A security official said combined operations are continuing in areas considered extremist group strongholds. The official confirmed that fugitives' relatives and friends have been arrested.

Police also distributed fugitives' photographs to all checkpoints, police stations and intelligence agents throughout Yemen. Additionally, Yemen's Interior Ministry announced a YR 5 million reward (\$25,600) for information on any of the Al-Qaeda escapees who broke out of their prison at intelligence service headquarters in

the southern Sana'a suburb of Hadda. Authorities said the men dug a 44meter-long tunnel from their cell to a nearby mosque using steel food pots and cooking tools.

Fugitives include Jamal Badawi, leader of the 2000 bombing of the USS Cole warship and the 2002 attack on French supertanker Limburg, and Yemeni-Fawaz Al-Rabyee, a

American wanted by the U.S. Al-Rabyee was sentenced to death in August 2004 following his conviction for leading a 14-member group linked to the Al-Qaeda terrorist organization.

### Defense presents case in Al-Ray Al-A'am trial

SANA'A, April 2 — At the West Capital Court's April 1 session in the Al-Ray Al-A'am newspaper trial, the defense, led by Allaw Establishment and headed by lawyer Mohamed Naji Allaw, presented its pleading. The paper is being tried for republishing insulting caricatures of the Prophet Mohammed (pbuh).

Defense confirmed a lack of material evidence due to absence of legal Sharia in the claim against the paper, asserting that republishing the caricatures to criticize them is not a crime, which is what the journalists did. Defense quoted a fatwa by prominent Islamic scholars, which validated republishing the caricatures to defend the prophet. It also presented Saudi Islamic Jurist 'Mufti' Dr. Suliman Al-Awdah, who republished the caricatures on Al-Arabia Satellite Channel, and Sheikh Mohamed Al-

Allaw described Prosecution's claim of applying Sharia law upon the defendants as a demand for the death sentence against them for the crime they allegedly committed, even if the charge is wrong. Allaw continued, saying the case is a criminal one, which Prosecution lawyers are unauthorized to file because it is the Attorney General's duty.

Allaw stated that he is defending the journalists because they republished the caricatures to defend the prophet, adding that he is addressing all citizens, whatever their position, so they can distinguish what they hear before making premature judgments. He gave the example of mosque preachers who incited citizens against the journalists, deeming them to be the same as the Danish journalists, even collecting money to indict them.

Allaw asserted that Prosecution lawyers' allegations are full of lack of knowledge of the basis for law and

Sharia. In return, Prosecution lawyers accused Allaw Establishment of receiving funds from foreign bodies, which they did not mention, to defend Yemeni newspapers that republished the caricatures, saying they have proof that Allaw Establishment received such sums, in dollars, to defend newspapers that insulted the prophet. They demanded that HOOD and Allaw Establishment be banned for this reason, as well as demanding that case documents, memos and correspondence be reviewed.

### **Court demands Watani** Bank compensate customers

SANA'A, April 3 — The State Security Specialized Penal Court demanded officials of Watani Bank for Trade and Investment repay depositors who lost funds when the bank collapsed a few months ago.

At its Sunday session, the court heard lawsuits filed by depositors against Watani Bank. The depositors' lawyer said Watani's management con-

spired with the bank's legal accountant to issue annual reports containing false data, adding that such data was contrary to that indicated by internal reports released by the Central Bank of Yemen (CBY) committee.

He added that Watani's false reports aimed to con customers and gain their confidence by concealing the bank's deteriorating financial status. Such conduct is punishable under the law.

### JMP accuses government of avoiding reform

SANA'A, April 1 Meeting Parties (JMP) accused the government of avoiding political reform and pushing national dialogue – underway for more than a week – to an impasse.

Yemeni Socialist Party (YSP) Secretary-General Yasin Sa'eed Nu'man alleged that the government is seeking to corner opposition parties by placing before them two choices: a political crisis or accepting deals and shady settlements that do not meet citizens' aspirations for political change.

"Both choices are unacceptable," Nu'man told reporters at a Sana'a press conference last week, accusing the ruling General People's Congress (GPC) of driving dialogue to an impasse. He

### **Arab Sisters Forum** outraged over Sawsen's case

SANA'A, April 1 — The Arab Sisters Forum (ASF) last Tuesday expressed grave concern about the case of Sawsen, who was raped by a sheikh in Amran governorate last

In a statement, the ASF affirmed that it is following up illegal procedures in Sawsen's case. According to the statement. Prosecution sent Sawsen to Al-Sabeen Hospital in Sana'a and issued a medical report stating that Sawsen was intact and not raped. The statement noted that Prosecution has not yet given a copy of Sawsen's case to her lawyer, Jamal Al-Ja'bi. "The procedure of issuing this medical report is legally invalid." Prosecution sent Sawsen to Al-Sabeen Hospital, even though a Russian doctor in Amran governorate issued a report. "The girl was sent [to Al-Sabeen Hospital] without informing her lawyer," Al-Ja'bi noted in the

The ASF affirmed that it will continue following up the case and form a defense team to bring out the

Meanwhile, Al-Ayyam newspaper reported yesterday that a team of human rights activists and journalists, headed by Al-Ja'bi and ASF representative Rana Ghanem, visited Sawsen and her grandfather, Hajji Muhsen Haider. They then headed for the Prosecution, where they met

Haider disclosed details behind sending Sawsen to Al-Sabeen Hospital, saying Dabwan sent him and Sawsen to Sana'a, pretending they would meet the ASF head and their lawyer. Pointing to Dabwan, Haider said, "This is the man who lied to me and Sawsen and took us to Al-Sabeen Hospital. It is he who sold my honor. I will complain to God and President Saleh about you." Dabwan confessed to sending Sawsen to Al-Sabeen in order to make a medical report on her case.

### 2 killed, 3 injured in traffic accident

SANA'A, April 3 — Two people were killed and another three badly injured in a Sunday afternoon traffic accident when a Toyota taxi drifted off the road and overturned in Hadda area, west of the capital.

Eyewitnesses attributed the accident to heavy rains causing the driver to lose control of the car which overturned on the roadside.

Police immediately rushed to the accident site and took victims to the hospital. Patrol captain Abdullah Hussein Al-Quladhi said high speed and heavy rains caused the accident. The driver drifted off the road and lost control of the vehicle, colliding with a roadside electrical post. He added that the victims were pedestrians.

Yemen's Interior Ministry revealed in its annual report that a traffic accident occurs every 55 seconds.

### Somaliland releases 15 Yemeni fishing boats and crew

SANA'A, April 2 — An official Yemeni agency reported that Somaliland released 15 Yemeni fishing boats and their crew. According to Yemen's Saba News Agency, the boats were seized in the Barbara seaport on the pretext that they were fishing in Somaliland waters.

Yemen and Somaliland exchanged accusations last month when the independent breakaway republic accused Yemen of fishing in its territorial waters. To the contrary, Yemen said Somali pirates kidnapped the Yemeni fishing boats and their fishermen on a fishing journey in Yemen's territorial

Somaliland later confessed that its forces seized several Yemeni fishermen and their boats. Somaliland's coast guard intercepted eight Yemeni boats - across the Gulf of Aden's rich fishing waters - under a campaign to enforce territorial sovereignty. Nine Yemeni boats were seized in February and their 84 crewmen deported.

Officials from Somaliland's capital, Hargiesa, visited Sana'a last month to discuss regional developments and solve the fishing dispute. A local newspaper reported Sunday, March 26, that Yemen and Somaliland signed a cooperation agreement on the fishing industry and fishing rights.

The agreement includes deals on fishery cooperation, particularly regarding information exchange, investment, organizing fishing processes and offering training opportunities to Somali workers. Yemeni Fisheries Minister Mahmoud Ibrahim Saghiri signed the agreement with Somaliland's Minister of Fisheries and Ports, Saeed Mohammad Raji.

Saghiri said the deal will solve many problems, stressing that his ministry is interested in strengthening fishing industry economic and trade ties, as well as working together to stop piracy in the Red Sea.

A former British protectorate in northwestern Somalia, Somaliland split from the rest of Somalia following a bloody civil war and the 1991 fall of Mohamed Siad Bare. The region's citizens declared the independent Republic of Somaliland in May 1991, which now includes six of Somalia's 18 administrative regions, roughly the region between Ethiopia, Djibouti, Somalia and the Gulf of Aden with an area of approximately 137,600 square kilometers.

Although not recognized by any government, Somaliland has maintained a stable existence with an elected president, Parliament and security services. It is argued that these achievements - without external help or intervention - are proof for others to recognize it as an independent

### Woman found dead on Sana'a street

Eyewitnesses said they last saw Katibah Ahmed Abdullah, 38, of Al-Mahwit, at 6 p.m. last Friday as she boarded a bus from Al-Kalfan area in the middle of Sana'a.

Her husband Ahmed Al-Khafash and children were starving at the time her body was discovered. Al-Khafash has been working as a building guard in the southeast area of town for four months.

The traffic officer told the dead woman's husband that they found her at 8 p.m. with a deep wound in the middle of her head. Her husband, 40, said his wife and children have no conflicts with

### Yemeni Popular Tales **Encyclopedia inaugurated**

SANA'A, April 2 — The Popular Heritage House (PHH) recently inaugurated the Yemeni Popular Tales Encyclopedia, considered the second such work of its kind. Composed by Arwa Abdu Othman, the encyclopedia is entitled, "Yemeni Popular Tales: 70 Popular Tales." Tales were collected and gathered from the late '80s to the end of the '90s with the help of older women, mothers and other women, and then recorded on paper and cas-

In the book's introduction, Othman refers to characteristics of Yemeni popular tales and elaborates on some of them. She also describes some famous Yemeni tales, classifying them into social, animal, puzzle, fun, popular beliefs and fairy tales.

Moreover, she mentions various obstacles in documenting such tales. Among them are limited individual efforts, primitive recording tools, absence of valuing such tales, Salafi culture's influence, villagers' poor living standards, poor recording of tales and lack of financial support.

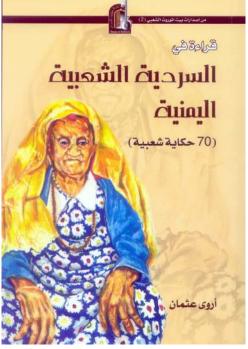
The book is not confined to describ-

ing the study of such tales, which is of a critical nature, but includes 70 new popular tales published for the first time. Othman has heard, pursued and collected such tales on a wide scale, but she affirmed that the situation was not appropriate for her to widen the book's scope as she had hoped. She hoped she would double her efforts to collect and document popular tales from all parts of

### Hadramout governor persuades teachers not to stage sit-in

In a meeting last week with Ageel Al-Attas, head of the Hadramout Syndicate, Governor Abdulgader Ali Hilal convinced teachers to cancel a planned sit-in in front of the government complex in Al-Mukalla.

The sit-in was intended to protest oppressions against teachers across the governorate, including replacing and firing some teachers, preventing them from signing the attendance list and threats and interrogation by security

Al-Attas said the governor pledged to stop all violations against teachers meant to break the strike - by security forces, education offices and general district managers. "If we don't see any action on the ground, then we'll decide what should be done," he added.

### Court demands Watani Bank compensate customers

The state's lawyer confirmed that the CBY is involved in the case because it granted Watani permission to perform banking activities without meeting business requirements stipulated by Banking Law No. 38, which states: "The paid capital of any bank must not be less than one million Yemeni Riyals."

In 1999, the CBY approved Watani's budget until 2001, despite many violations associated with it. It continued approving Watani's budget until 2004, despite the bank's declining financial status resulting from performing activities without limit.

The depositors' lawyer urged the court to hold Watani Bank's governor, its management board and its legal accountant accountable for releasing reports containing false data. He demanded the court withhold Watani's assets in the CBY, keep them in the court's treasury or invest them to earn interest for Watani customers.

He also requested the court oblige the CBY to explain Watani's financial status and assessment of it, as well as extract guarantees from the CBY until returning deposit amounts to customers. The court released two suspects jailed on commercial guarantees.

In the past few days, depositors have threatened to stage official protests and sit-ins at the Cabinet and Parliament. They vowed to hold sit-ins at the Presidential Palace if their issues remain unconsidered in order to claim what they lost due to Watani's bankruptcy.

Watani Bank collapsed last December, announcing its failure to fulfill its financial obligations to its customers as stipulated by Articles 43, 44 and 46 of 1998's Law No. 38 concerning banks and financial institutions. The CBY decided to enact firm measures against the bankrupt bank and end its officials' authority.

### JMP accuses government of avoiding reform

As opposed to "one-person rule," the parliamentary system will help alleviate suffering, which has been a historical problem for Yemenis. Getting rid of one-person rule has been a demand for reforming Yemen's national movement since the 1930s, the JMP said in a statement. The current system has led to concentration of power in the president's hands, thereby edging out institutions' role and making corruption rampant in all government administrative units.

Opposition leaders commented that the current governmental system has become an instrument to monopolize, take control of power and then bequeath it to sons. Such a system

forms the best cover for corrupt officials to practice illegal earning while chaos spreads nationwide at the expense of the rule of law.

As part of their efforts to conduct free and fair local and presidential elections, opposition parties met with President Ali Abdullah Saleh last Saturday, reaching an agreement to form a legal committee to discuss Supreme Commission for Elections and Referendum (SCER) violations.

During the meeting, Saleh emphasized the need to conduct free and fair Mohamed Al-Sabri, Secretary-General of the Nasserite Organization's Political Unit, said in a statement to Al-Sahwah Net.

Al-Sabri pointed out that the JMP revealed its proposal to ensure free and fair local and presidential elections and suggested forming a committee from lawyers and judges to discuss SCER violations.

Saleh and opposition leaders discussed political guarantees and procedures to manipulate them, agreeing to postpone other issues necessitating constitutional amendment to future meetings.

upcoming presidential represents a turning point for broad political conflict. Independent presidential candidates number almost 10, while the Joint Meeting Parties (JMP) has yet to name its candidate. Abdurrahman Al-Hamdi, former MP (1993-97) and brother of former President Ibrahim Al-Hamdi (1974-77), last week joined the list of presidential candidates.

The Yemen Times forwarded Al-Hamdi the following questions to unveil the reasons behind his bid for candidacy and identify policies he intends to adopt to rescue Yemen from corruption and an ailing economy.

The public has the impression that most presidential bids up to now are not serious, including yours. How do you react to this?

It is difficult to answer this question, as such a widespread issue requires study and research to unveil the reasons why people have this viewpoint. Saleh's long reign, coupled with lack of wellestablished democratic conventions, as well as lack of experience regarding peaceful transfer of power, are some of the reasons encompassing the highest political post with horror. Concerning my nomination, I am serious enough to compete in the presidential race.

#### Why did you make a bid for the presidency and what are the motives behind your bid?

There are reasons galore, one of which is that we want to establish presidential candidacy as a constitutional right, whether for me or any citizen having the desire to run. My participation, along with others, intends to highlight the principle of peaceful transfer of power, moving it from

theoretical clauses into real life. Peaceful transfer of power must not remain a slogan for media practice.

What is of great importance is that Yemenis live in difficult and unprecedented conditions impacting political, economic and social situations. Absence of law and order, as well as corruption became the main law, while order was the exception. Public property

### We hope to take the peaceful transfer of power from the level of slogans to reality.

was plundered and mishandled as if it belonged to officials.

All of these greatly infringed upon the community, with the poor constituted the population's overwhelming majority while a small minority controls wealth and power. Government officials monopolize trade activities using their power to defeat any rivals. International reports on Yemen's deteriorating economic situations and freedoms are viewed as a thorough description of the condition. We know reforms persist, particularly in political and economic areas, and therefore, must not be delayed any longer.

As a Yemeni citizen, I believe continued silence and absence of reaction to what happens in everyday life mean conspiracy against public

You have been absent from political participation since your 1993-97 Parliament post. Now, after several years, you return as a presidential candidate. Does this affect your competition?

Possibly, but I think continued media presence and political presence in government institutions have become formal. Parliament seems to have a weak, if not passive, role, driving the country backward via its legislation. What is of crucial importance is that Parliament is controlled by the executive authority and presidential directives. The situation caused Parliament to lose credibility and forced me not to stand again in parliamentary elections. I did not withdraw because of the loss; rather, I had a great opportunity to win.

We need to contemplate about ourselves and our presence must be effective. I believe I can make the public hear my address and program in the upcoming presidential race. Winning is not the ultimate standard for success, but real competition in the shadow of free and fair polls will be considered, if it happens, a victory for the democratic

#### How do you assess Yemen's deteriorating political and economic situation, as highlighted by many indicators?

The reform process is a complete system that should be implemented now and political reform is the gate for other comprehensive reforms. Political reform begins with agreement on reforming the electoral process to be conducted freely and fairly and free of vote fraud. Only this can achieve reforms.

#### What is your attitude toward the political reform program presented by the JMP? Will you coordinate your attitude with the opposition?

I asked for dialogue with the JMP to jointly coordinate the upcoming presidential race. I requested the JMP recommend me as the opposition presidential candidate, particularly as it has not yet named a candidate to represent it. All political programs serve the country, whether presented by the opposition or other parties. The most important thing is that all parties showing their programs must have a clear vision regarding their work priorities, as well as clarity to convey them into real life.

### I asked the (JMP) to recommend me as the opposition presidential candidate.

In your press statement, you mentioned that you have an ambition to aspire to former President Ibrahim Al-Hamdi's presidential reign (1974-77), described by many Yemenis as "The Golden Reign." If you win, what are the most prominent policies you intend to resume?

The current situation is totally different from that of the '70s, but there are numerous principles for the state. I will work hard to reestablish the state of law and order that represented Ibrahim Al-Hamdi's program, which contained the following prominent features:

1- Reestablishing the principle of equal citizenship and justice, as it was a state for citizens and not a state for sheikhs, as experienced now.

#### 2-Reconsidering the status of law and order.

3-Reconsidering achievements of the September 26 and October 14 Yemeni

- 4-Updating and making the judiciary totally independent.
- 5- Fighting corruption and maintaining public funds.

6-Activating control and monitoring and affiliating the Central Organization for Control and Audit (COCA) with Parliament, ensuring that COCA reports are published and implemented.

I plan to work hard to finalize democratic construction and expand local governance to reclaim all authorities, enabling the public to directly elect governors. The Shoura Council must be elected with equal shares to all governorates. I plan to announce a complete electoral program in coming days.

If you or another candidate other than the current president, who has been in power for 38 years, wins, do you think you will enter the presidential palace peacefully?

We have to be optimistic and hope affairs go easily. This is the most challenging test for our democratic experience.

religious and ethnic groups to keep himself in power. "Today some Americans ask whether removing Saddam caused the divisions and instability we're now seeing," Bush said. "In fact, much of the animosity and violence we now see is the legacy of Saddam Hussein." Senate Democratic leader Harry Reid

accused the American President of sending "mixed messages" on Iraq that are hurting the country's chances for success. "The president can give all the speeches he wants, but nothing will change the fact that his Iraq policy is wrong," said Reid, D-Nev. "Two weeks ago, he told the American people that Iraqis would control their country by the end of the year. But last week, he told us our troops would be there until at least 2009."

On the other hand, many Iraqis are frustrated that the Americans just don't get it. "It is true that we got freedom after the war, but uncontrolled freedom chaos and violence," says Bashar Mohammad, the owner of a Baghdad Internet café, who lost five relatives in car bombings and sectarian killings.

"The new generation is growing on violence and sectarian ethics, and this will affect Iraq for many years to come," he

"We are living a more devastating war every day," Mohammad said.

The Iraqis also worry over the role the occupation is playing in their country. Many Iraqis believe that what's happening now is very convenient for their occupiers. It is all very good if the Iraqis are kidnapping and killing each other. This enables the occupiers to act as the neutral foreign party that promotes peace and understanding between the Iraqis, who up until the invasion, were very peaceful and under-

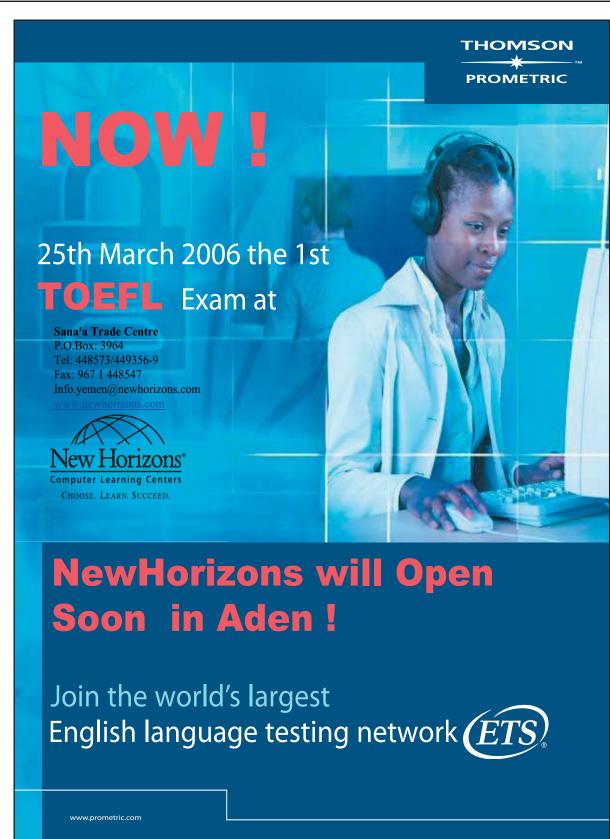
After the invasion, the Iraqis' hopes have diminished to nothing. They no more want freedom or democracy, they just need to live a normal life. "We either die by the Americans, the security companies, which kill you and leave you laying in the street, the Iraqi police or ... the death squads," says Laith Mohammad, 32, a student in Fallujah.

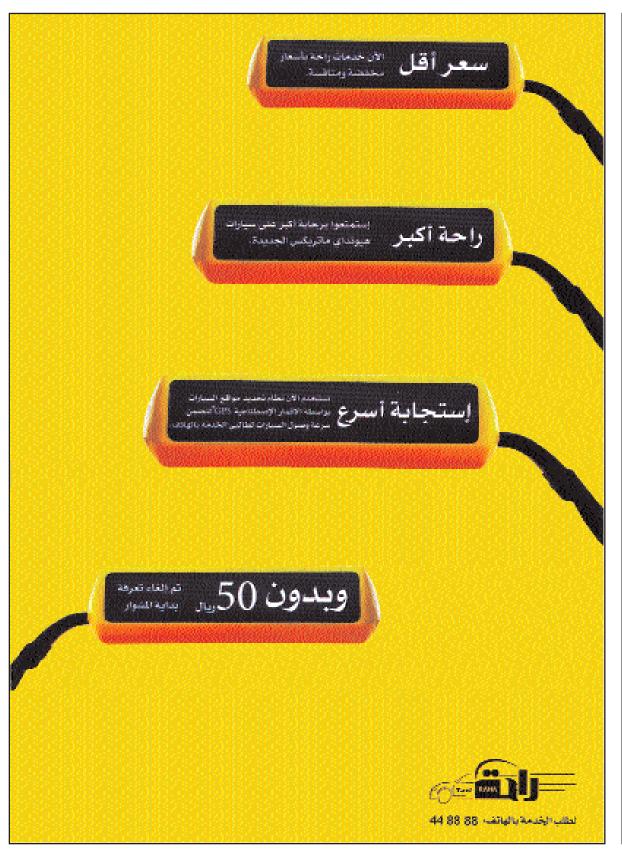
"Three years after the American invasion of Iraq, I have only one wish. I do not want democracy, food, electricity and water. I just do not want to die."

## Aden's children in international focus

The International Committee for Children's Rights expressed concern about sexual exploitation in Aden. Aden's children not only face sexual abuse, they suffer social segregation as well.

Juvenile Care Center source confirmed that the government turned a deaf ear to warnings from the International Committee for Children's Rights. The source also expressed concern over the rampant phenomenon of children's sexual exploitation. "It is on the increase, differing from last year. There is no precise statistic," the source stated.

According to non-governmental organization field studies, 10 boys ranging from age 10 to 17 were at the center at that time. However, some child activists were skeptical of such studies. They believed the studies did not target all children at the center, justifying that the government handles child sexual exploitation with sensitivity.

The international committee, which warns of child sexual exploitation, said Yemen's government had no information and did not record such phenomena. A 2005 International Children's Rights report mentioned many cautions concerning childhood situations in Yemen, particularly in Aden. Top concerns were about sexual exploitation, child labor and disabled children.

The report was prepared over five years, during which the committee closely observed the situation of children living in Yemen. Also during those five years, according to international analyses, Yemen did not conduct field studies to collect information or statistics on the type of sexual exploitation and violations children face.

An exception was a preliminary study conducted in Aden and Taiz by specialized psychiatrist Jamila Mohammed Nasser. The study focused on female inmates' children in Aden's Al-Mansoura Prison as a result of sex-

ual abuse and/or prostitution. Some study samples were presented at a 2003 regional symposium on child sexual abuse in Yemen and Jordan.

Supervised by the Yemeni Society for Psychological Health, another statistical study on the psychological aid telephone hotline program referred to the number of child sexual abuse cases. These were two remarkable studies among a fair number submitted to the committee.

The studies did not focus on child sexual abuse; rather, they were about Aden children's civil rights, child labor, freedom, physical punishment, family environment and alternative recreation and health care. They also tackled prospects for child and adolescent psychological services, combating female circumcision and Aden's education perspective.

The committee expressed grave concern about the situation of Yemeni children. It also confirmed that Adeni girls, like other Yemeni girls, suffer social segregation because they do not enjoy the same rights as their male counterparts. According to the committee, the rate of young girls in basic education is nearly the same as that of boys. During the past academic year, there were 6,671 boys and 6,264 girls in school. However, the number of girls decreased to 4,872 by sixth grade. Female student dropouts climaxed at ninth grade, with 3,764 girls dropping out of school, according 2003-2004

Moreover, the committee further stressed children's rights, freedoms and physical punishment. It previously stressed the same issues in 1996 and 1999, expressing grave concern at the absence of birth registration. Aden used to be advanced in this respect but now is deteriorating.

According to 2004 official statistics,

some 8,210 births were registered: 4,382 boys and 3,828 girls. In its recommendations, the committee denounced insults, negligence and physical punishment, basing its stance on last year's United Nations regional conference on violations against children held in Cairo.

The committee held parents accountable for insulting their children and depriving them of social care and a domestic family environment. It also referred to elementary health care and welfare, which the analytical report called "problems of disabled children, health services, adolescent health, damaging practices and mothers' rights to living standards." The report mentioned disabled children, asserting that there are no accurate statistics on the number of disabled children in Yemen. "Yemen's government has no compre-

hensive or sufficient policy toward disabled children. Programs to incorporate the disabled into education are absent."

The report wished to assign an adolescent health program. Such a program must be cared for and developed by the committee's recommendation, which stated that Yemeni children in general and adolescents in particular sorely need sexual, psychological and reproductive health awareness. In this regard, the committee depended on non-governmental organization reports indicating an increase in physical, psychological and behavioral diseases among adolescents. It called for training and qualifying secondary school teachers in chronological and behavioral characteristics, as well as behavioral and psychological disorders.

The Yemeni Society for Psychological Health experimented in

some Aden schools, establishing a behavioral center for psychological guidance and a telephone hotline program for children's psychological aid. The committee thought education should have a special focus, as it is the basis on which all solutions rest.

Aden is an important cultural and educational center because it is Yemen's commercial and economic center. Previously, it was the political capital of South Yemen. According to official estimates, Aden's population is 590,413. The percentage of children under age 15 is 37 percent, while the percentage of those aged 18 is 45 percent. According to 2003-2004 statistics, there were 6,671 boys and 6,624 girls in basic education schools, while there were 10,789 boys and 9,526 girls in secondary schools, indicating that the drop out rate among girls is 70 percent.

There are only two government vocational centers and the number of other educational centers does not meet local needs.

The committee expressed concern over arbitrary migration to Aden, which poses negative consequences for Aden's development and runs counter to the governorate's ability to provide services and living standards which are on the rise due to inflation. The committee's concern grew as it discussed the government's reform program, believing the discussion to protect the governorate's children is fruitless.

At the national level, the committee mentioned that 326,608 children under age 14 are working in various jobs, 167,774 of whom are girls and 158,834 are boys, according to 2004 statistics.

## Commemorating Al-Zubairi

or non-Yemenis living in Sana'a, Al-Zubairi is the name of a main street crossing the capital from Bab Al-Yemen (the southern gate of the Old City of Sana'a) in the east to Asir Mountain in the west. But do they know that Al-Zubairi was a prominent Yemeni poet, revolutionist and intellectual figure or that last Saturday, April 1, marked 41 years since his assassination?

Mohamed Mahmoud Al-Zubairi was born in Boustan Al-Sultan in Sana'a in 1910. He received his basic education at Al-Madrasa Al-Elmiah, one of few schools in Yemen at that time. He showed a tremendous talent for poetry at an early age, but like many intellectuals at that time, he was very concerned about the deteriorating condition of Yemen and its people's misery. He went to Egypt in 1941 where he found a suitable environment for improving his thoughts and political awareness. He met many Yemenis there who were against the Imam and his way of ruling the country which resulted in suffering and hardship for Yemenis.

Al-Zubairi began his activities by criticizing the regime, highlighting Yemen's poor condition and calling Yemenis to be freed from illiteracy, poverty and dictatorship. His writings and speeches found enormous support from many Yemenis, both inside and outside Yemen.

When Al-Zubairi returned to Yemen, he was thrown into jail. After his release, he continued writing and his poems became very popular. Under pressure from the Imam's regime, he escaped to Aden to join the Yemeni Freemen Movement, becoming a founder of the Yemeni Freemen Party in 1944 and the Voice of Yemen Newspaper dedicated to showing Yemenis their rights and calling for a constitution and radical reforms. Following the 1948 revolution's failure, Al-Zubairi fled to Pakistan, living in exile there for many years while working as a teacher and broadcaster. However, he continued his struggle and became one of Yemen's prominent opposition leaders calling for revolution and a republican system between 1952 and 1962. After the 1962 Yemeni revolution, he was appointed Minister of Education and a member of the presidential council.

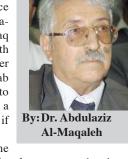
Al-Zubairi was assassinated April 1, 1965, while trying to convince some tribes in Barat (Al-Jawf) to discontinue their support of the monarchy against republicans. He was against Yemenis fighting each other and wanted the civil war to end. When news of his assassination spread throughout the country, citizens thought it was an April Fool's joke. They simply could not believe that the peaceful leader, whose only weapon was poetry and dialogue, had been killed. Over the years, Al-Zubairi formed an image of a leader who did not remain in the office preaching, issuing orders or seeking political or financial gain from his long history of struggle. Rather, he died on the field, trying his best to give Yemenis what they deserve: freedom and development.

Al-Zubairi also is considered the foremost Yemeni poet in the first half of the 20th century. Full of passion, his poetry echoed his revolutionary anger toward the Imam's oppression and national struggle. It was a source of inspiration and motivation for Yemenis to continue their uprising against a dark and backward era, and most importantly, to keep faith in their vision of the future for generations to come.

# Where are Arabs on the anniversary of Iraq's occupation?

hree anniversaries have passed since the occupation of Iraq exploiting its oil wealth and dividing it into smaller parts while other Arab countries from the Gulf to the Atlantic Ocean are in a state of slumbering as if they are dead.



Capital cities of the invaders witnessed massive demonstrations and their inhabitants denounced Iraq's occupation, insisting on ending the unjustifiable oppression while Arabs remain silent. No Arab capital witnessed its people organizing a demonstration to reflect public feelings or express outrage at what happened and still is happening to Iraq, which has entered a new stage of civil war due to the invasion.

The strangest thing is that we hear socalled political and intellectual leaders saying that what happens in Iraq concerns the Iraqi people, an ugly saying similar to what we hear from Iraqis who are loyalists to the occupation. These agents point the arrows of words at the chests of their Arab brothers interested in the Iraqi issue. They forget that the multinational occupation is merely a foreign intervention arousing malice from other nations having no relations with Iraq, either in language, ideology or the neighborhood. How is this believed not to arouse the outrage of neighbors putting their

hands on their hearts in fear of what is taking place in Iraq, as well as in fear of the possibility for invasion to reach their homes?

What happens in occupied Iraq is not a local affair, similar to what happens in Palestine. The occupation and their agents in the two Arab countries promote the idea of a private affair. If what is seen in Iraq happens between Iraqis themselves without any foreign intervention, it will be the right of Iraqis to tell others: "Let us do what we want, since this is our private affair and it is we who know the circumstances and problems of our country." The matter is relatively similar in Palestine.

But what happens here and there is

foreign occupation threatening Arab world unity, as foreign presence in Arab lands poses a threat to Arabs' future. Neutrality and indifference are limitless treasons.

Let's return to the pessimistic anniversary and Arab regimes' silence. Citizens in occupation capitals proved to be the first to stream into streets to protest against the unjustifiable invasion, denouncing the false justifications upon which the occupation and its consequential tragic scandals were based. Where were Arabs on the anniversary's eve? Were they awaiting approval from the superpowers or had frustration reached its climactic point, compelling Arabs to keep silent, showing no reaction to what happens in the occupied

Arabs' passive stance on the third anniversary of an occupied Arab nation increases shyness and disgust at current circumstances the Arab world is experiencing and the collapse to which they will lead.

### State of suspense in the Middle East (1-2)

he current international situation, especially at the regional level, represents the ideal example of what is called the state of suspense. Files are open and issues unsettled ands all are waiting.

Here is the Iranian western confrontation in a way bearing worrying forebod-

ings. The situation in Iraq does not seem approaching settlement in the short-run. In addition, the Palestinian occupied territories looks to be having a situation of waiting that may take long space of time and the Syrian-Lebanese relation enters an uncomfortable stage of for all parties, as well as the situation in Darfur is heading for a new turning whose probabilities look to be ambiguous and with dangerous outcomes.

In Yemen, the situation is not showing good omens between the ruling party and the opposition, especially before preparations for the local and presidential elections, at a time the supreme commission of elections does not read well the regional and international variables. The opposition has not yet announced its candidate for the presidential elections particularly under the situation of increased number of independent nominees and the absence of the ruling party's convincing the president to be its candidate to name the alternative.

All these situations collectively form what is can be called the state of international suspense against which all possibilities are probable and also all results are contingent. Reviewing aspects of suspense prevail these selected samples

of spots of tension in the Middle East can be summarized with the following points:

First, We do not believe that breaking through the Iranian revolution will be an easy thing because the "struggling state" is, by its nature, founded on rooted principles difficult to negotiate with or to get

concessions from. Though I personally feel concerned regarding an example of the Iranian president Ahmedi Najad, I know that the Iranian political decision is not in the hands of the president of the republic alone. There is the supreme spiritual leader and with him a strong group of governance strong establishments, more capable of formulating the final stands. A few years before I had he opportunity to visit Iran to see what I did not expect to see. There I found out a strong state, coherent society, advancing economy and the woman proceeding on liberation. I also discovered that Iran is the second Asian state, next to India, in cinema industry. It has the best program for family planning in the Islamic world. Then I believed that the western media try to underestimate efficiency of the mullahs' rule and to paint news and information with whimsical political tincture. Therefore, I think that Iran will go ahead on its road despite that we concede that Israel strongly seeks to deal a blow to the Iranian nuclear installation, it might do so, but an American involvement in Iran similar to the Iraqi type seems to be an impossible development, based on our reading of the international attitude and its ramifications. No doubt the entire world follows up that heated confrontation, particularly after the European stand has got close to the American stand versus the Iranian nuclear file that had been forwarded tot the UN Security Council in a step to intimidate Iran and in complication of the tense attitude between it and he west in general and the United States in particular.

Second, Iraq and its situation have entered the darkest spot of the tunnel. Let's be specific and call things by their actual names. Iraq is governed by Shiite imams and is hit by Kurdish-Arab, Shiite and Sunnis, conflicts, a situation heralding the most dangerous consequences. It is quite enough to ponder what we term the mosque war, an unprecedented development of bloody conflict taking place on the land of two rivers. Moreover, the victims of violence are on the increase and I do not think of a possible near end of this situation produced by the American invasion. Added to that are the strong charges of vexation and despair greatly dominating over the sons of the wounded homeland. As there seems to be a conflict on the person of the prime minister, the ongoing conflict in Baghdad is closely related to each party's use of its strength and political weight for a new formulation crystallizing the Iraqis perception of what the future Iraq can be. Although the Iraqi question, with all of its complications, seems still improbable of solution despite of the efforts to settle it, that will not affect the future of the great Arab people of Iraq.

(Rachel) stood in front of an Israeli bulldozer in an attempt to prevent the driver from destroying a Palestinian home. The bulldozer drove over her and then reversed and crushed her a second time). But look at the nerve of the WSJ editor in twisting the facts and smearing Rachel at the same time as just one of those "anti-Semites". To the WSJ, one would just like to say that this observer is more Semite than anyone their editor means by this worthless slander. Moreover, Rachel is more of an inspiration then any of the devious icons that make up the Israeli Lobby including Tanaro or any of the other mouthpieces of the Israeli Lobby. ### **Public Diplomacy &** Dialogue with the West

ast week I read a short piece of news in Akbar al-Youm criticizing the British council and accusing it of targeting the Arab youth and their religion. The newspaper published group pictures for some youngsters from some Arab countries including Yemen, alleging that these young people have relinquished their religion, being the overall aim of the British council which organized a study trip for them; it is to distort their identity and morality.

I have really felt disgusted after reading the paper. There is nothing wrong in the pictures that can tell us how the West is trying to penetrate these youngsters. They were on a visit to Britain under a program meant to bring the young people from different countries together so that to establish understanding and friendships.

Again al-Mithaq Weekly of the ruling party last Monday accused our colleagues Jamal Amer and Hafiz al-Bukari of being agents for foreign forces. The two guys were invited to take part in some media activities in the US which were described as suspicious trips. Amer is visiting the US under the International Visitors Program which is sponsored by the State Department. I visited the US under this program in 2002 and I found it a very excellent study, meet ing journalists from different countries and getting to know very closely the media in the US and how it functions. The Program is meant for different target groups including parliamentarians, businessmen, legalists, journalists, teachers, academicians...etc. I remember after I came back, one of my colleagues asked me "how was your CIA training work-

shop?" This is the totalitarian culture that always feels afraid from the outsider culture and explains everything in the context of conspiracy. They think themselves we are the target of the West which is working hard to destroy us. This is complete nonsense and hallucination.

These people claim our "noble moral values and culture" is the target of the West, which is stereotyped as our number one enemy. Suppose this is the case and that the West is trying to intellectually invade us with its "perverted morals". Then, why should we feel afraid as our ethics and morality can defeat such an immoral culture? Otherwise, our culture had better vanish and wither away, if it is unable to stand before the so-called waves of Western attempts to control us. If the West wants to defeat us morally, why do not we try to do the same and target the Western people by similar programs? I know the West would like us to know it better and therefore, is concerned to fund such programs because it is concerned with correcting its image in our minds. However, the Arab and Muslim countries are not wiling to do the same, exposing

the Western people to the reality of Islam and Muslims. The political regimes in these countries are, on the contrary, ready to pay some writers to exercise lip kissing and praise their "great achievements".

The antithesis of our argument is the fact that we use all the products of this "enemy" and benefit from all its technology and try to deny this reality. We still live in our past and its distinction and therefore, we do not want to acknowledge the betterment of the West and its modern technology. We are the weakest politically, economically, technologically ...etc. We forget about this distinction of the Western civilization, remembering only "perversion".

We always complain that there is lack of understanding between us and the West and that there is an urgent need for dialogue to bridge this break. The recent crisis of the cartoons of Prophet Mohammed has really shown how wide the gap between the Muslims and the West is.

I believe part of the dialogue between us and the West is exchanging visits of luminaries and intellectual people, including the youngsters. These visits are important in the sense it enable us to understand the West as it is, not as it is imaged to us; a perverted culture that has no meaning. We have been told that the Westerns live the life of animals being emotionally and spiritually dry. We have studied that we are the best. owning the absolute truth. When you get to know the Western people, you know how wrong these conceptions

I remember when I wrote that it is only dialogue that can work out in the cartoons problem. I was lashed out at by some people, including university professors; they said these Western people understand nothing but force. Blindly, we have held the Danish society accountable for the cartoons problem and called for boycotting it.

Our real enemy is not the West; it is rather these political regimes which have done nothing to develop their nations. They have wasted our money on their families and their cronies, hampering any efforts of development and democratization. These regimes want to maintain he relationship with the West at the diplomatic level and are cautious of any direct interaction between people. Of course, they are not afraid we might be morally perverted by the West as some allege. Rather, they are afraid we get exposed to the Western democracy, media freedom, good governance, human rights and many other values that distinguish the

To drive the point home, dialogue and open debate between the people in the West and in the Muslim and Arab countries is very much needed and the only way out to erase misunderstanding. It is, in fact, public diplomacy that will help us directly communicate and understand each

The democratic institutions established over fifteen years ago in Yemen may shrivel up and blow away without anyone noticing. The country may sink further into chaos as it slowly implodes and the oil

But do not place your bets just yet. Nationalism in Yemen is alive and well. In a region widely lacking habits of regular transition of executive authority, Yemen may become the first to achieve popular empowerment through democratic processes. There's a Presidential election coming in September.

The nature, character and history of Yemen make it the most likely Middle Eastern nation to evolve politically without external stressors. The last chaotic fifty years of Yemeni history were defined by people committed to the nation. Yemen, in existence since pre-Islamic times, has already been a leader in the new age of participatory legitimacy in the Middle East if only by absorbing the rhetoric and forms of democracy. With the unity of North and South Yemen in 1990, the Yemeni people came to a consensus for democracy and since have internalized the legitimacy of its underlying premises.

The failure of democracy to thrive in Yemen has been attributed to political tribalism. The Yemeni political system operates from the top down whereby elites from nearly all important power centers are co-opted by the regime, trading patronage for loyalty. As a result, many local and national leaders do not advance local and national interests as defined by the population but rather advance regime interests onto their constituencies. Much dissatisfaction in Yemen comes from the failure

of the government to implement and follow its own laws. The new Yemeni revolutionaries are those who seek to advance the rule of law, the equality of citizens, and the duty of representaoperate in the national

The Yemeni opposition has turned from negotiat-

ing with the regime to negotiating with the people. The days of trading journalists for buildings have apparently passed. The opposition is demanding a fair election, starting with a non-biased electoral commission, a linchpin of the process. At worst, the opposition by contesting the election may force important incremental changes on the political process. At best, they'll win.

In the 2003 parliamentary elections the opposition parties received nearly half the votes (but only a quarter of the seats). The main hurtle for an opposition candidate in the current presidential election may be having enough time to inspire the trust of the nation and develop a bond with the voters. Moving itself beyond criticism, the opposition has advanced a reasonable reform platform which advocates centering more authority within Parliament to decentralize executive power, enabling badly needed political and economic reforms. Parliament refused to empower itself.

Dominated by the ruling party, the GPC, over two thirds of the members of the Yemeni parliament are Sheiks, Sheiks in business, or the sons of Sheiks. It is this parliament that must approve the candidacy of the opposition candidate. Reformers within the GPC are continually stymied by their own party and are threatened when they speak out.

Like the regime, some Yemeni political parties are tribal in nature, undemocratic in practice, and operate from

tem. At the last GPC conference, the forms of democracy were in abundance as delegates voted for predetermined candidates, except for those who were appointed. The GPC said at that time that it will nominate president Saleh as its candidate although President Saleh has

a top down authority sys-

repeated stated he will not nominate himself.

If President Saleh stands by his pledge to step down from the presidency after 28 years, he would empower Yemeni citizens and all Arab peoples through out the Middle East. His action would mark a defining moment in modern history. It would be a source of pride for the Yemeni people and would define Saleh forever as a great statesman who deferred power to progress and modernity.

But even that would not be enough. Additionally President Saleh would have to intervene to enable a free and fair election by ending the harassment of journalists, opening the broadcast media to the opposition, and ensuring the impartiality of the electoral commission and other governmental institutions like the military.

The military leadership is dominated by President Saleh's relatives. In the last election, the military and security forces were instruments of intimidation and enforcement for the ruling party. Yet the military may be infused with enough nationalism, patriotism and strength to stand apart from the election and allow the process to proceed neutrally. In this election, the choice for Yemen's warriors is whether they will protect the powerful or the voters.

The US and EU are taking a strong stand with Belarus, condemning its unfair presidential election and subsequent crackdown on protesters. The Yemeni people deserve this level of

international support as well. All people have a right to freedom from intimidation in making their political choices, and international election observers are sorely needed in the villages as well as the cities. The US, which exerted a great deal of international public diplomacy in the run up to the Egyptian presidential elections, is silent regarding the upcoming Yemeni elections, possibly because the major parties have not announced their candidates yet.

If Yemeni patriots in all regions, political parties, institutions and civil society are to coalesce, they need not only international support, they need popular support. Analysis has shown that only popular pressure that can force reform on an authoritarian regime. As the symbolic funeral procession shows, some citizens are demanding that the parties function democratically and their representatives represent them. The Yemeni people are already agents of modernization, and have generated demands for equal rights in the work place, free speech, the participation of women, and the advancement of human rights. And if they demand a fair election now, they can set in motion a century of freedom for themselves and the entire region. That would require quite a bit of heroism as the authority can be quite brutal, but Yemenis are known for their

Can a Parliament full of Sheiks reject political tribalism, can a president return power, can a loyalist Cabinet speak for the people, can the military defend the citizens, can the opposition lead, can the partisan media take a national view, can the electoral commission refrain from endorsing a candidate, and can a nation mobilize itself from pure frustration? Yes, it's possible in Yemen.

# Children looking for "hope"

y daughter is the reason I'm fighting to establish this center," Arwa Thabet said talking about what led her to establish Hope Center to treat children suffering with cerebral palsy (CP).

Thabet gave birth to Nafha seven years ago. Due to lack of oxygen during the hospital delivery, Nafha's brain was damaged. Since then, Nafha has suffered a wide range of difficulties, from a clumsy walk to inability to speak or swallow.

Thabet and Nafha traveled to many countries looking for treatment; however, they found that CP is permanent and recovery is not possible. "Through my travels, I understood that there is no certain treatment yet for CP. Certain types of physical therapy are the only way my daughter still has a chance to reach her ultimate ability and live independently without others' help."

#### They never have seen the light

Thabet returned to Yemen with hope that she finally had found the answer that may save her daughter's life.

"I was shocked that there are many children in Yemen suffering with this disease. Most got it due to doctor errors during delivery." Thabet said such children remain isolated in their rooms, unable to integrate or adapt to their community, as there are no schools, parks, restaurants or even any transport taking into consideration their disabilities.

"Some mothers stop going outside the home because they cannot leave their children alone nor find a place TYPES OF CEREBRAL PALSY

they would feel comfortable with their children who need constant watching and care."

#### **Obstacles and difficulties**

Thabet decided to establish the first center specializing in cerebral palsy treatment. "As a mother, I believe my daughter and other children living with this disease still have a chance to express themselves and assimilate into the community. They have the right to be visible and they have the right to get treatment designed to minimize residual physical disability to live independently."

Thabet recently obtained a license from the Ministry of Health and Population, although she already has received and registered cerebral palsy patients. "When I began the first step to establish this center, I faced many

measures I must follow and a lot of money to pay only to obtain the licenses to open the center officially," Thabet confirmed.

Obtaining the licenses was not the only difficulty Thabet faced. "The first problem I faced was that I couldn't find experts or doctors specialized in treating this disease in Yemen. Therefore, I had to correspond with specialist medical centers abroad."

Thabet collaborated with Egypt's Hope Center, which sent four physical and occupational therapists to help children develop necessary skills for daily life activities. "Besides doctors, I had to bring in physical therapy equipment from outside Yemen and that cost me a lot."

Thabet confirmed that the center, which began operating in October 2005, daily receives more than 40 CP cases, with more than 70 patients on the waiting list. "Although my center is new, we receive a lot of children daily. Some mothers told me their children never had seen sunlight until they brought them to this center. That proved that we need such centers in Yemen to help these children."

The center offers four weeks (six days a week, six hours per day) of Intensive Therapy at a cost of \$2,500. "However, some children suffering with CP are poor and their parents cannot afford the expenses of this treatment. Others have lost their parents, so the center offers them free treatment, sometimes covering transportation expenses from their home to the center," Thabet noted.

In this regard, former minister of Health and Population Dr. Najeeb Ghanem stated that there are more than 100,000 Yemeni childern infected by CP. "Most of these children belong to poor communities. Their disabilities create an additional burden on their families; therefore, they are considered the poorest among the poor," he said

### Hopes and...

She expressed her hope that she can expand the center and its services offered to CP children. She said successful cerebral palsy treatment requires input from a variety of professionals.

Physicians address health issues like poor eyesight or restricted joint motion. Physical and occupational therapists help children develop skills necessary for daily living activities. Speech pathologists deal with swallowing and speech dysfunction. Psychologists and educators work with emotional or learning difficulties. Nutritionists ensure normal growth.

Such professionals and numerous others work together as a team with the child or adult to help the individual achieve as much independence and competence as possible.

Thabet insists that family involvement in treatment, especially with children, is an essential component. With therapy, training and community support, most individuals with cerebral palsy can lead meaningful and productive lives.

### What is CP?

Cerebral Palsy, a range of neuromuscular disorders caused by injury to an infant's brain sustained during late pregnancy, birth, or any time during the first two years of life. People with

cerebral palsy have a wide range of difficulties, from a clumsy walk to an inability to speak or swallow, caused by faulty messages sent from the brain to the muscles.

Medical studies refer to the three most common forms of cerebral palsy: spastic, athetoid and ataxic. An individual may exhibit a combination of these forms, called the mixed type.

Spasticity symptoms typically include reduced movement due to stiff or permanently contracted muscles. Spasticity is associated with damage to the brain's nerve fibers which carry messages for voluntary motor control.

Athetoid cerebral palsy is characterized by uncontrolled movements. This form is caused by injury to the brain's nerve fibers responsible for inhibiting muscle movement.

Ataxic cerebral palsy is unusual, occurring in only one percent of cases, and results when the cerebellum (the area at the base of the brain) is injured. Since the cerebellum maintains balance and precision of body movements, affected individuals have difficulty with coordination while walking and moving upper limbs.

Although the term cerebral palsy primarily refers to problems with muscle tone and movement, other disorders may be present. Mental retardation is common but does not necessarily result in all cases. Other associated problems include epilepsy, visual disturbances, hearing impairment, language difficulty and slow growth.

### 90 percent of CP infections are due to doctor errors

Physical therapist Dr. Mohammed Abu Zaid confirmed that most Yemeni children at the center suffer CP due to delivery complications. "Eighty-five percent of children at the center suffered lack of oxygen during birth, whereas five percent needed blood transfusion during birth but didn't receive it immediately."

He also pointed to prenatal causes

such as an infection spreading from mother to fetus, maternal stroke preventing proper blood supply to the fetus, exposure to environmental toxins or problems in brain development. There is also meningitis (infection of the brain or its protective covering) or head injury due to accident or heredity

Abu Zaid said the intensive treatment program begins with a detailed evaluation to determine the child's abilities. That is, gross motor ability, language ability and social intelligence. The child's muscles then are evaluated thoroughly. "We evaluate each joint to test weakness, shortness, stiffness and stability. We then put together a program in accordance with the evaluation."

Abu Zaid said the training is based on increasing the child's potential and using his or her good potential to reinforce the weak ones in order to reach a functional stage like sitting or walking. "Therapy aims to give the CP child a big push to depend on his abilities. Therefore, we determine exercises incorporating the child's participation."

Thabet said many cerebral palsy causes are preventable, especially those occurring at or after birth. Good prenatal care has been shown to minimize the likelihood of premature births, new vaccines against Hemophilus influenzae have reduced incidences of meningitis and family support programs have reduced the number of severe child abuse cases.

### First National Olympic Committee elections in Yemen due April 9

SANA'A, April 2 — Yemen's Ministry of Youth and Sports has arranged to conduct the first Olympic elections in Yemen April 9, sports officials said Tuesday.

Officials noted that Yemen's Olympic activities have entered a new stage following National Olympic Committee (NOC) General Assembly reshuffling according to International Olympic Committee (IOC) principles. Prior to this, general assembly council members as well as the secretary-general were appointed by the Minister of Youth and Sports.

The April 9 elections are viewed as an important step toward completing Yemen's Olympic infrastructure and improving the Olympic Games through the NOC's programs, NOC Secretary-General Mohamed Abdullah Al-Ahjuri stated to Saba News Agency. "NOC programs interpret International Olympic Committee objectives and content reflecting the culture of love and peace among youths worldwide through the noble Olympic competi-

Al-Ahjuri pointed out that the NOC worked to publish IOC concepts and embody them via numerous activities organized at the local level. The NOC had international participation, which helped it earn international respect and support to improve Yemen's sports infrastructure.

Approving certain NOC policies and mechanisms over the past few months constituted a new turn for Olympic Games and programs nationwide, Al-Ahjuri added.

He mentioned that the NOC General Assembly will involve 18 internationally recognized unions, in addition to other unions interested in raising awareness about Olympic sports, including sports medicine and media

The general assembly will elect the NOC management board, the general secretary and executive officers in

compliance with locally approved standards. Twenty percent of NOC General Assembly posts will be allocated for women interested in sporting

The NOC General Assembly meeting last October approved elections and canceled the appointment policy after discussing the new system for

Olympic Games in Yemen. The General Committee formed a special committee at the beginning of 2005 to study the NOC system and amend it to comply with the IOC.

Yemen joined the IOC in 1981 and first participated in the 1984 Olympic Games in Los Angeles.

### The father of free Yemenis commemorated

he anniversary of martyr Mohammed Mahmoud Al-Zubairi's death was marked yesterday with a ceremony involving Yemeni intellectuals, academics and writers at the Culture House in Sana'a. A writer, poet and most importantly, a leading revolutionist, Al-Zubairi was assassinated in April 1965.

A number of Yemeni literature specialists, especially Al-Zubairi literature, participated in the event, including Dr. Abdul-Rahman Al-Amrani, who wrote a book on the art of Al-Zubairi, Dr. Abdul-Wase' Al-Himyari and Khadeeja Al-Mughanig, as well as several other intellectuals and researchers who shed light on different aspects of Al-Zubairi's life and the issues he treated through his literary works. The ceremony also featured recitals of excerpts from his poet-

Al-Zubairi was born in Boustan Al-

Sultan zone in Sana'a in 1910 to a family known for its scholars, clerics and poets. Orphaned, he learned Islamic sciences and kept the Qur'an by rote.

Al-Zubairi's first remarkable event as a poet was during his 1938 pilgrimage with martyr Abdullah Al-Wazir, during which he was reported to have praised Saudi Arabian King Abdulaziz bin Saud with a reputable poem. He remained in Mecca until leaving for Egypt in 1939 where he joined Dar Al-Uloom (House of Sciences), became acquainted with Hassan Al-Bana and joined the Muslim Brotherhood Movement. During his stay in Cairo, Al-Zubairi and his Yemeni companions were reported to have formed the first organized opposition movement against the imamate regime in Sana'a in 1940.

He returned to Yemen in 1942, proposing reform suggestions to the imam, who became enraged and jailed him with several youths in Al-Ahnoum Prison. After about nine months' incarceration, he was released and versified an oft-quoted poem, from which the following is excerpted:



Mohammed Mahmoud Al-Zubairi

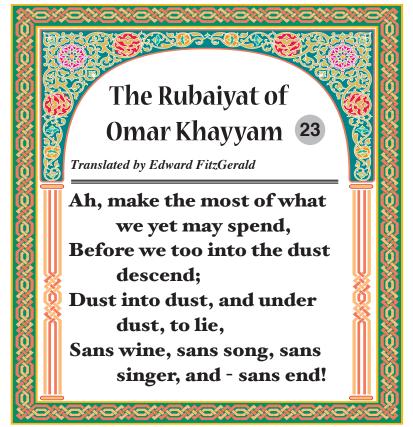
"We left prison with uplifted heads like lions coming out of their woods/ Marching along swords' blades and heading toward death's mouth/ Disdaining life if smeared with tyrants' oppression and terrorism.'

Al-Zubairi continued to struggle with his companions and after the Sept. 26, 1962 revolution occurred, he returned to Sana'a and was appointed Information Minister and then Deputy Prime Minister.

As the situation remained unsettled following the revolution, as the republic was attacked by royalists, Al-Zubairi attempted to solve disputes between belligerent parties. One ominous day, while moving about Barat area in Al-Jawf north of Sana'a calling for tribesmen unity, he was assassinated.

#### Works

Al-Zubairi championed the issues of Yemen, Arabs and Muslims, as manifested in his poetry, fiction and speeches. He wrote many works including three poetry collections: "Prayer in Inferno," "Poetry Revolution" and "Point in Darkness," and the novel, "Waq Al-Waq Misery." He also wrote several political works and cultural letters such as, "Imamate and its danger to Yemen," "Major Stratagem in Arab Policy" and "The People's Claims."



### The invincible Hab Fort

ab Fort is one of Yemen's ancient forts located atop a lofty mountain strategically overlooking Ba'dan district in Ibb province. At an elevation of approximately 2,200 meters above sea level, Hab Fort extends from the east to the west for two

The famed fort is bounded by Al-Du'ais area and Al-'Awd Mountains to the east, Maidan area and Ba'dan Mountain to the west, Al-Sabrah district to the south and Al-Harth area to the

#### Historical significance

Hab Fort has its own significance as it is one of the most invincible strongholds in Yemen. Paralleling Al-Ta'kar Mountain on the west, Hab Fort contains a spacious area with a long wall built on the edge of the mountain's flat surface. At the foot of the mountain is a local marketplace called Tabee'.

The mountain is very steep with precarious areas. It stands prominently and has the potential to survey a large area of Ba'dan and Al-Sha'ir districts. Ancient Yemenis knew that it could best serve as a fort. The present fort has a great gate, a number of storage houses, a mosque, annexes, steam baths and tanks. The fort also contained an old school built by Ali bin Abdul-Rahman bin Mohammed Al-Nidhari.

Some historians claim that the name "Hab" (Arabic for grain) was given to the fort because it was the only fort for storing grain. However, the fort also was militarily and strategically significant, which is why kings and invaders focused on it. There are two ways to access the fort, one of which is modern and can accommodate cars and the other is a snaking old stone-paved path.

Hab Fort also is significant as host of the first Ibb Tourism Festival.

### **Hab Fort features**

Located on the southern side, Hab Fort's only gate is arched and built of trimmed stones and strong wood planks hewn from local trees. The fort's stones were brought from far away because there were no such rocks in the local area.

Above the gate is a guardroom with an inside door with surveillance holes overlooking the gate's front area. Five rows above the gate is a stone belt with stones protruding like pyramid tips and six rows above this belt is another decorated stone belt.

The gate's walls contain small surveillance holes, as well as holes on both sides of the gate for archers to counteract any attack against the fort. A corridor extending inward from the gate zigzags so entrants must go left, then right and then left. Behind the fort's main building is an annex used for sentries and as a watchtower.

### The wall

Hab Fort contains a long wall, running, as aforementioned, along three sides of a cliff, with the fourth side overlooking a deep abyss that cannot be breached. The fort's wall contains architectural characteristics of ancient construction. Although the fort is invincible by virtue of its natural features, ancient Yemeni architects further fortified it by means of a wall of trimmed stones.

Cylindrical multi-story towers are

built at intervals in the wall. Each tower's top floor is used to monitor the landscape and spot approaching enemies. Hab Fort's towers are designed differently than other Yemeni forts in that each overlooks the other so they can watch out for the adjacent one.

Fort walls also feature narrow surveillance holes. Another of the wall's defensive traits is that unfixed stones protrude from its top row so enemies cannot climb over it. A further line of defense is located behind the wall in the form of mud piles. Apart from the wall's defensive function, its aesthetic design and harmonious structure, Hab Fort reflects the greatness of ancient

### The mosque

Within the fort area is a small mosque, a small square yardless room built of stone and a thin layer of qadhadh (a local substance resembling plaster used for cementing bricks) and decorated in its interior. The mosque is domed with a small crescent atop it and has no verses or decorations on its external walls. The mosque's door is rectangular and arched.

Inside the mosque, one can see an arched mihrab (a niche at the front of the room where the imam prays) with a plain belt around it. At the dome's interior side are some rectangular shapes. The mosque contains tank and bathroom facilities, the latter of which are ruined and need rehabilitation.

### The main building (the palace)

The palace is a large three-story building built on a square plot beside a small deep pond. The palace gate is on the western side. The palace's ground floor contains several rooms before which are several pillar-borne plaster-covered neatly built arches.

The second and third floors are divided into several rooms, kitchens, bathrooms and storage rooms, with a hall lying in front of each group of rooms. The ceiling is built of wood and covered with a plaster-hay mixture. Unfortunately, the ceilings of some rooms have collapsed, requiring urgent maintenance.

The palace is significant as it is among the famed palaces of Ba'dan district which is a part of Thi Ru'ain region, which in turn is under the umbrella of the wider term, "Al-Kila'."

Yemen's renowned historian Abu Al-Hassan Al-Hamadani mentions, "Thu Ru'ain is a region inhabited by Al-Adwi tribesmen and other minorities. Within this part lies Hab Mountain..."

History books indicate that Hab Fort was the seat of influential pre-Islamic Yemeni ruler, Yarim Thi Ru'ain, whose grave was identified there in Islam's early years. The fort also was mentioned in great works of Arab historians and geographers. "Hab is a famous citadel in the land of Yemen," Yagout Al-Hamawi

### Mahmoudi treachery

Hab Fort is said to have continued functioning normally until Hijra year 968 when it is reported that Mahmoud Basha, an Ottoman ruler in Yemen, launched a military campaign against cleric Ali bin Abdul-Rahman Al-Nidhari, who was lord of the fort at the

The story is that Mahmoud and his troops closed in on the fort wherein Al-Nidhari and his soldiers were entrenched. The invading troops besieged the fort on all sides but couldn't conquer it. However, the number of those inside the fort was so many that food and water could not suffice them.

Therefore, Al-Nidhari thought to reconcile using Ismaili cleric Mohammed bin Abdillah bin Ja'far as an interceder. Al-Nidhari agreed to leave the fort with his family to a place of his choosing. When the reconciliation plan was approved by both sides, Al-Nidhari sent his son to Mahmoud, who honored him

and gave him a pledge to honor his

The next morning, Al-Nidhari himself went down with a group of his men to Mahmoud. Being in his hands, the latter ordered them all executed. He then ordered his troops to climb up to the fort and pillage it. Thus, history mentions one of the most notorious stories of treachery and unfaithfulness.

#### Manmade ponds

Within the area of Hab Fort are four manmade ponds used to store rainwater. They are several meters in diameter and as deep as three meters. All are open and named as follows: Al-Tawilah (The Long), Al-Asaliah (The Hazel), Jarat Al-Dar (Neighbor of the Palace) and Jarat Al-Jami' (Neighbor of the Mosque).

At 60 meters long, Al-Tawilah is covered with a layer of qadhadh and built of stone on three sides (eastern, western and southern) while the northern area is part of the rocky area. The pond is rectangular and seems to extend from west to east. A trace of a ditch is discernable, running from the pond to the main palace gate. Al-Tawilah is one of the fort's largest and its depth cannot be determined exactly as its bottom heaves under a heavy weight of mud, weeds and trees accumulated over the years. However, its apparent depth is three

Small in size with spiral steps to its bottom, Jarat Al-Jami' is another square pond located beside the mosque.

A small square pond, Jarat Al-Dar lies right beside the palace, once the property of Al-Nidhari. Apparently, it was the pond from which palace dwellers took water. Steps go along its western wall to the bottom. The number of ponds in the fort shows its dependence on rainwater.

The ponds were used for a variety of purposes such as drinking and washing, as well as irrigating plants and watering cattle and livestock. It was the custom of Yemenis to preserve and store rainwater for their year-round use. In some parts of Yemen, dams were constructed, as it is the case with Marib Dam. However, in such a lofty place, ponds carved from hard rock were the feasible alternative to store water.

Part of the fort's invincibility lay in its ability to store food and water; therefore, Hab Fort contained approximately 16 underground cisterns to store grain and prevent it from perishing. As previously mentioned, many historians consider that Hab Fort basically was associated with grain, with one historian saying it was the only place where grain was stored in ancient times.

Grain harvested from lands belonging to the Fort's lord were collected from nearby areas and transported to the fort where they were stored in underground cisterns carved out of rocks. Each cistern stored one particular type of grain. Cisterns were approximately five meters deep, narrow at the mouth and wide inside. Channels connected the cisterns in the interior.

The fort's 75-year-old guard, Abdul-Rahman Shamsan, said the fort's most spacious cistern is called Al-Jahim (Arabic for inferno), explaining that it is named thus because it is large and can store a large quantity of grain. Shamsan, who has been at the job for about 30 years, said some of the watchtowers are named. He pointed to them, uttering some of their names: Shamsan, Rafi' and Al-Saq. According to him, the palace itself was named Al-Qaflah and the building annexed to it was called Al-Saqah.

### **Langston Hughes** recital in Sana'a

March 30 — The Oriental Cultural Organization held a recital at the Culture House in Sana'a, in which U.S. professor Marilyn Putton recited 14 poems by black American poet Langston Hughes, while Dr. Abdul-Wahab Al-Maqaleh read their Arabic translations.

Putton and colleague professor Dick came to Yemen, visiting Sana'a University's Faculty of Languages where they conducted a three-day English language teaching workshop. Al-Maqaleh seized the opportunity and suggested holding the poetry

Following the recital, the audience expressed satisfaction with such an activity, praising it as "a distinctive cultural contact.

"I kept listening to the poems while I was contemplating the picture of the black poet with his friendly smile," one attendee said.

Putton said Hughes liked to travel and he traveled a lot. "I don't think he came to Yemen, but now he has come in another way.'

Prior to the recital, Putton introduced the poet and his contribution to liberation of his fellow black men, as well as the profoundly humanistic aspects of his poetry.

Among poems recited were: "The Negro Speaks of Rivers," "Mother to Son" and "Dream Keeper."

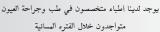

pril Fool's Day, also called All Fool's Day, is a day celebrated in some countries on April 1. Unlike other days, April Fool's Day is not a holiday. The day generally is observed by playing a practical joke on a "victim" who soon becomes known as an "April fool."

The day is marked by committing hoaxes and other practical jokes of varying sophistication on friends and

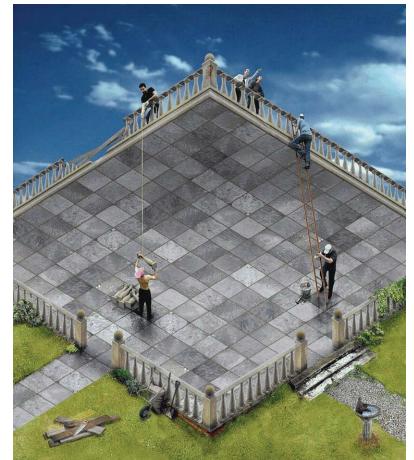


neighbors, or sending them on 'fools' errands,' the aim of which is to embarrass the gullible.

April Fool's Day is insignificant in Yemen, as many people do not believe in, care for or know about it. Perhaps, some youths from the new generation have begun to pay attention to this

Amel Mohammed says she never played any jokes or fell victim to April Fool's Day. Nasser Al-Hamami, 24, says those who care about the day are mostly youths studying in university or secondary school. "Older people never joke or lie on this day," Al-Hamami added. Hayyaf Abdulrahman, 28, says, "Some consider April Fool's Day an opportunity to play jokes on friends or relatives, but such jokes originally are lies. I myself lie on this day and I once fell victim to lies on this day as
