## **Agreement reached on Election Commission crisis**

# Gov't seeks to amend Election Law

SANA'A, July 30 — As the government last Tuesday transmitted its second project, which includes amending 30 items in the Election Law, to Parliament to complete constitutional procedures in order to issue the new law, Parliament declared extending its session until next week to approve the amendments.

The Joint Meeting Parties already rejected a government project last November stipulating that election committee members be judges, demanding the election committee be comprised of politicians, not judges, according to a party principle agreement. However, the ruling General People's Congress Party believes the committee should be comprised according to the number of 2003

parliamentary election voters.

Yemen's state-run Saba news agency reports that the government project includes completely amending 23 items and eight clauses in another seven items, pointing out that the amendments will "fill shortcomings of the law that have appeared over the past period, as well as enhance guarantees for free and credible elections, thereby implementing European Union recommendations following the most recent presidential election.'

According to the news agency, the amendment project essentially focuses on widening the scope of contesting against local and parliamentary public electoral candidates during the nomination period. It also guarantees impartiality in public works, public financing and official media during election camto file management complaints during the election process and organize related procedures.

The proposed amendments will "enhance the election committee's independence and impartiality, organize election security, expand local and international observation of the elections and specify the observers' rights and commitments," Saba reported.

#### **Election Committee crisis ends**

An official source in the ruling party says this government project involves the "agreement of all political parties in forming the election commission."

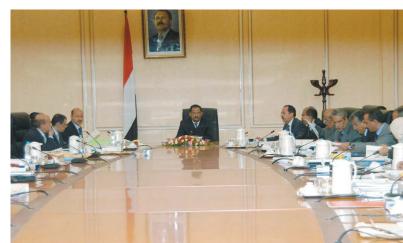

> According to Jubari, Parliament last Tuesday approved extending its session to Aug. 6 in order to discuss the government's amendment of the Election Law, which is scheduled for approval next week, and elect new members to the new Election Commission.

# Relative optimism as humanitarian aid slowly finds its way to Sa'ada

SA'ADA, July 30 — The current situation in Sa'ada is slowly stabilizing after the president's declaration that ended the war on July 17th, but restrictions, high prices and damaged property still makes life hard for the gover-

nate's residents.

The 8 p.m. curfew is still in place and locals do not attempt to go outside after 9 p.m. fearing renewed attacks by Houthi rebels, in addition to the threat of security arrests if they are suspected of aiding the Houthis.

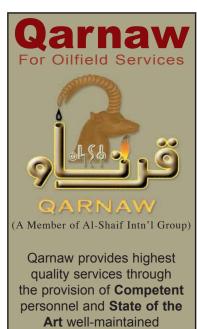
Food prices are still high and much more so than in the other governorates; petrol is brought Saudi Arabia and diesel from Hodeidah.

"The price for a 200 liter container of diesel reached YR 22,000, from [its previous price of] YR 7,500," said Abdullah Hussein, an employee at Al-Talh Hospital in Sa'ada.

Telecommunication networks were blocked during the war, and when the peace was declared, some lines went back on briefly for three hours. However, now residents say that communication lines – specifically cellular phone lines - have ceased to operate once more.

Throughout the conflict there were area was made official. severe electricity problems. Now, because of the use of generators, there Aid is on the way is electrical power again. In Sa'ada city there were medicines available, but because of the scarcity of diesel fuel, Al-Salam Hospital was shut down. It remains closed to this day.

Mansour Al-Shara'abi, Motamar.net correspondent, explained that residents who had fled because of the war are gradually returning to their homes, yet many have discovered their homes were ruined. Though it was difficult for residents to find food initially because of the roadblocks isolating the governorate, things are now - gradually - returning back to normal.

Abu Bakr Al-Qirbi, the Minister of Foreign Affairs, explained that Yemen has called on the foreign community and donors to help Sa'ada recover. "Now that peace has been restored overall in the area, we need to cooperate together to rebuild what has been destroyed," he said.

On Monday, Al-Qirbi and Deputy Prime Minister Rashad Al-Alimi met with the international donor community in Yemen to explain the situation and ask for support to mitigate the damages in Sa'ada.

On Tuesday evening, the governor of Sa'ada, local security and administration in the governorate met with the humanitarian organizations in Sa'ada, as well as some of the locally-based civil organizations to coordinate humanitarian assistance.

The meeting was positive overall, and the call for humanitarian operations to recommence working in the

Islamic Relief arrived in the area this back there," he added past Tuesday and the International

Committee of the Red Cross resumed its work in Sa'ada on Wednesday. Other relief organizations are still working on their plans to travel to the war-torn area

The United Nations has not yet sent its security team to Sa'ada as of Wednesday night. The security team assesses the risk for UN employees and arranges for the needs assessment team to be sent afterwards.

Khalid Al-Mowalad, Yemen Country Director at the Islamic Relief organization, explained that the situation is calm now, even in areas like Harf Syfian where a lot of the damage had been especially recently.

"We have done extensive focus group discussions with men and women in the largest Internally Displaced Persons (IDP) camp in Al-Anad, where around 800 families are located," said Al-Mowalad. "During the last five days, some of the locals went to inspect the damage in their homes and returned to the camps because there was nothing left for them

There are seven IDP camps in

Sa'ada, containing a total of around 1,500 families who all need food, medicine, blankets and shelters. "Some people have fainted because of hunger,

epidemics spread especially because of the four weeks siege, and now there is much help needed," concluded Al-Mowalad.

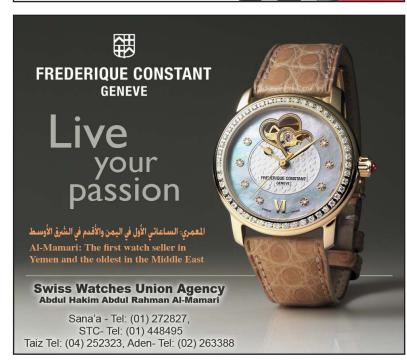














## "Know About Business" in Yemeni vocational institutes

SANA'A, July 29-Starting Saturday, the first batch of teachers from vocational and technical institutes will get to "Know About Business," through a project designed to promote Yemeniowned small businesses.

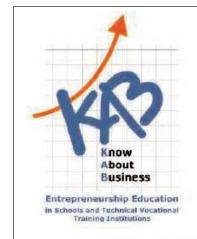
Know About Business, or KAB, is a entrepreneurship development training program launched by the International Labor Organization (ILO) for teachers of vocational education and secondary education. The program consists of 120 hours of coursework for young students between the ages of 15 to 18 years

The KAB program directs students to understand the role of business in the society, its contribution to the wealth of nations and its social responsibility; it helps create entrepreneurial behavior and informs students about how an enterprise is supposed to function.

These teachers will receive an intensive training for two weeks. The 28 participants are teachers in technical and vocational institutes from all around the country. They will then turn around and teach their own first and second year students in their institutes about how to start their own businesses that offer vital - and lucrative - servic-

"This is important for us because as a Ministry we are the body most concerned with providing the Yemeni market and even neighboring countries with skilled labor. There is an imbalance currently existing between the universities and vocational training because the majority of Yemeni youth would prefer to get a university degree rather than a skill. Our job is to change this," said Dr. Ibrahim Omar Hugari,

According to Hugari, such a subject will help Yemeni youth change their attitude towards technical education and become more independent as skilled workers who can start their own

Two KAB trainers from the ILO will arrive on Thursday and dedicate one month to train two batches of vocational teachers on how to teach this subject in their institutes. Although the curriculum is already set through a standard syllabus, there is room for customization during the discussions and group work. The two ILO trainers will be heading to Egypt next to provide the same training there. Yemen will be among the first few Arab countries that adopts this program into its educational system; Syria and Oman have already implemented KAB in their educational systems.

The training is funded by the Social throughout Yemen.

Fund for Development and organized by the Fund's Small & Micro-Enterprise Promotion Service Agency (SMEPS). This is the pilot stage of the project and throughout the academic year, experts from Small and Micro-Enterprise Promotion Service and ILO will evaluate its success encouraging entrepreneurship and creating business opportunities in Yemen.

"We understand that Yemen has its own particularities and there are things that you can never teach in a classroom. However, the aim of this subject is to change attitudes and encourage Yemeni youth to explore the possibility of creating small and micro-enterprises instead of waiting to be employed," explained Ahmed Abdulbary Ali, the KAP project officer at SMEPS.

He further explained that once the training proves successful, efforts will take place to include it in classrooms

# Detective says girl disappeared intentionally

TAIZ, July 27—Detectives in Taiz were finally able to find Sawsan Al-Maqtari, 19, who disappeared for 11 days, though now the details of her disappearance is question; her father said that Sawsan was kidnapped because of a revenge feud, while detectives said that the girl hid herself intentionally.

After police found Sawsan, Colonel Yahya Al-Haisami, the head of the Security Department in Taiz governorate, said that Sawsan's disappearance wasn't a kidnapping, confirming that one of her friends who worked in a telecommunications center persuaded her to go together to a house where she got to know a group of young men who subsequently hid her from sight throughout the 11 days she was absent from home.

Al-Haisami said that nine people, including two women, were caught together with two vehicles, the first of which carried Sawsan to a house belonging to one of the suspected kidnappers. "The primary results show that Sawsan wasn't kidnapped; she disappeared for other reasons," said Al-Haisami.

Sawsan's father, Jamal Al-Maqtari, had previously informed security

forces that his daughter had been kidnapped by unknown people in order to take revenge on Sawsan's mother, who testified as a witness for the prosecution in criminal court on a theft case.

Abdullah Abdul Rab, the attorney representing Taiz's Criminal Prosecutions Office, said that the girl refused to come back home to her father and instead demanded to be sent to the Taiz Central Jail, though her father denies this.

Jamal Al-Maqtari said that he met his daughter early Monday morning in the criminal investigations premises in

the presence of the lead detective who promised to hand Sawsan over to her father by the end of the work day. When Al-Maqtari came back at 1:00 p.m. to take his daughter, he was surprised to find that she was already put

Sawsan's attorney accused the security apparatuses of attempting to mislead public opinion by shifting the case from a kidnapping to an intentional disappearance. He said that security officials want to show how dutifully the security officers perform their tasks and are consequently denying the occurrence of any criminal activity.

Jamal Al-Maqtari has already demanded his daughter's immediate release and called for investigations to be conducted in order to clarify the details of Sawsan's kidnapping. He accused the security forces of switching the case from kidnapping to a deliberate disappearance despite the evidence to the contrary.

"Criminal detectives investigated my daughter's case after they found her without a lawyer," said Al-Maqtari, adding that Sawsan's lawyer along with a number of the local council members were barred from speaking with the girl soon after she arrived at the security administration headquar-

## Two famous political prisoners will wait until November to appeal their cases

SANA'A, JULY 30 - Since the Yemeni judiciary will be out of session beginning on the 1st of August, political prisoners Abdul Karim Al-Khaiwani and Fahd Al-Qarni will have to wait until November to continue their appeals trials in Sana'a.

On Tuesday, the Court of Appeals, which specializes in terrorism issues, delayed hearing a request filed by iournalist Al-Khiwani's defense lawyer to release him from custody until November 2008.

Al-Khaiwani is the former editor of Al-Shoura newspaper and the winner of Amnesty International's special He was sentenced to six years in prison by a primary court in Sana'a on June 9, after he was convicted of forming an armed group to attack Yemen's interests and supporting Houthi rebels in the Sa'ada war in the

north of Yemen.

During the all of his trials, Al-Khaiwani's defense lawyers rejected charges that he had backed Houthi

They said that materials about the insurgency in the north that were found in his possession were needed for his work as a journalist, and demanded his release from prison.

Yesterday, Sana'a primary court delayed both hearings for comic singer and actor Fahd Al-Qarni and Al-Khaiwani.

Al-Qarni was tried and convicted in a Taiz court and sentenced to one and award for Journalism Under Threat. a half years in prison plus a fine of YR 500,000. Al-Qarni was also ordered to hand over all recordings of his productions and had a bail set on the condition that he would not reproduce any of his work.

ruling General People's Congress party (GPC) accused the singer, who is affiliated with the Islah Islamic opposition party, of motivating people to carry out armed revolt, resisting the government system and calling for revolution and secession. His prosecutors also said that Al-Qarni insulted the GPC as well as President Ali Abdullah Saleh in his perform-

In Al-Qarni's first case in Taiz he was prosecuted by the Ministry of Culture, and in Sana'a he is being tried with the same accusations by the Authority for Printing and Press.

The arrest of the two men raised both criticism and concern among journalists, Members of Parliament, human rights activists and civil society organizations in both Yemen and abroad towards Yemeni policies on

# Sayoun suicide bomber identified, 12 other men suspected of aiding operation

SAYOUN, July 30 - The perpetrator of the suicide bombing in the city of Sayoun in Hadramout governorate last Friday, July 25, has been identified, while Al-Qaeda in Yemen has claimed responsibility for the bombing that killed four and wounded 12 others.

The four that perished are believed to be security soldiers who worked at the targeted security camp in Sayoun. The injured included other security soldiers and several local women living near the camp. The blast was so strong that it damaged eight homes as

Al-Qaeda in Yemen took credit for the suicide bombing in an emailed statement that included a purported photo of the suicide attacker, identified as Ahmed Bin Said Omar Al-Masjari, also known as Abu Dajjana Al-Hadrami, according to a CNN report. "This attack was carried out in revenge for our brothers whose blood is on the hands of the infidel Yemeni forces," the statement said. The Ministry of Defense-affiliated newspaper and web 26September.net reported that the suicide bomber was a third-level medical student at Hadramout University and was born in Saudi Arabia.

Yemen's state-run SABA news agency said the bomber drove a 2003 KIA through the security camp's gates, which prompted security soldiers to open fire on the bomber.

26September.net that the government is following 12 suspects who may have helped the suicide attacker, but have not arrested anyone yet. Two of the alleged planners are Saudis and one goes by the name of Mohammed Al-Qahtani. The other Saudi suspect's name was not released, nor were the names of the 10 other Yemeni suspects.

Previously, another group calling themselves the Yemeni branch of Islamic Jihad took credit for the attack in a press release published on the internet. "We congratulate the attacker on [attaining] paradise," the statement

The operation comes within the

context of "defending Islam against rallies and celebrations that pollute the minds of our sons and daughters through singing, impudence and mixing of the two sexes," which may be a reaction to an annual tourist celebration held in Mukalla, the capital of Hadramout, on July 17 featuring artistic, cultural and sports activities, as well as folk dancing and traditional foods.

This attack follows other hard-line events such as spontaneously formed vice monitoring squads in Hodeidah and Aden, as well as the creation of a Committee to Protect Virtue and Fight Vice sponsored by well-known cleric, Abdulmajid Al-Zindani.

# **Construction begins on** Yemen-Djibouti Bridge

ADEN, July, 29 — The Middle East Group for Saudi Development has officially begun the construction of the construction of a new hanging bridge joining the African continent to the Arabian peninsula across the Red Sea. There will also be two industrial and tourism-based new cities built on both sides of the bridge, which will cost around US \$20 billion to \$30 billion.

The declaration came during a celebration organized by the Middle East Group for Saudi Development in Djibouti, which was attended by Djibouti's Prime Minister, Deleita Mohammed Deleita and the chairman of the Middle East Group for Saudi Development, Tariq Bin Laden. According to Saudi Arabia's Al-Watan newspaper, Tariq Bin Laden has bought 1,500 square kilometers in Yemen and 500 square kilometers in Djibouti to start construction on the industrial port cities.

The project will extend from Bab Al-

Mandab Strait in Yemen thought Djibouti on the horn of Africa and is expected to take from seven to nine years to complete. The bridge will be nearly 30 kilometers long, comprising of girder and suspension bridge structures and be able to carry a six-lane highway and four light rail lines, as well as water and oil pipelines. The second phase of the construction project will be divided into smaller constructions to make the rest of the bridge's length.

Bin Laden has granted the design and management contract to Noor Al-Medina Construction Company, which is based in California in the United

Noor Al-Medina Company in opened the project up to a board of international experts to submit ideas on the design, operation and management of transportation traffic.

The two construction companies said the major role of the project is to develop Yemen and Djibouti's economies and to recast the two countries as centers for global trade. They

added that this will have a positive effect on the nearby countries and their residents as well. Bin Laden signed the contract in March, accompanied by representatives from the Noor Al-Medina Company and Djibouti's president, Omar Ismail Jila.

Tariq Bin Laden said the project will provide more than a million job opportunities in Yemen and half a million in

It is anticipated that about 100,000 cars and 50,000 rail passengers will cross the bridge daily in addition to thousands of tons of cargo in trucks and rail wagons, according to Muhammad Ahmed Al-Ahmed, CEO of Al-Noor Holding Company

Observers believe that the project will enhance the commercial exchange between the Arab Peninsula and countries in the Horn of Africa. The bridge will also help millions of African Hajjis get to Saudi Arabia for the pilgrimage, as well as facilitate the transport of agriculture and livestock from the African continent to the Gulf region's markets.

Gov't seeks to amend Election Law, while Yemeni women seek role in 2009 elections

According to the law, the Election Commission is to be comprised of nine members chosen by the president from list of 15 members presented by Parliament.

Election Commission Secretary-General Shayif Al-Husseini points out that announcing the Election Commission next week will provide the opportunity for the upcoming elections scheduled for April 27, 2009, to be held on time, adding that the current commission's general secretariat already has prepared technical and administrative orders to conduct the upcoming elec-

"The Supreme Commission for Elections and Referendum, which will commence working by the end of August, will form the observation com-

mittee, since the other technical and administrative preparations already have been done by the current Election Commission's general secretariat," Al-Husseini noted.

Yemeni women seek their role

Ramzia Al-Eryani, head of the Yemeni Women's Union, recently stressed the importance of raising women's awareness about their electoral rights in order for them to actively participate in the upcoming elections.

In a workshop, Al-Eryani noted that an evaluation of the women's union's internal elections last June increased social awareness toward women's issues and rights, which is vitally important in enabling them make decisions and implement strategies related to women in the union.

Observers maintain that women's political situation in Yemen recently has decreased, especially given that women hold only one of 301 seats in Parliament and only two ministry positions within the current government.

According to official data from the most recent local and presidential elections held Sept. 20, 2006, the number of women registered on electoral rolls is 3,900,565 out of 9,247,370 voters.

The first report recently issued by Al-

Jazeera Center for Studies and Human Rights criticized women's situation on the agenda of parties and political organizations, pointing out that women "don't exist in any leadership positions, except in five out of 12 parties in Yemen." The report points out that illiteracy is one outstanding obstacle hindering Yemeni women's advancement in society. It further noted that the number of women is disappointing because they comprise the majority of Yemen's illiteracy rate, which is 39.3 percent in urban areas and 78.2 percent in rural

#### Yemen, GTZ discuss supporting parliament committees

Parliament Deputy Speaker Mohammed al-Shadadi reviewed Tuesday with the GTZ Office Director in Sana'a Thomas Hart means of availing from German experience in supporting the parliament's committees.

The German official acquainted the Deputy Speaker with its country's experience in the legislative field, particularly laws related to health insurance and public health.

The meeting also discussed aspects of bilateral cooperation and exchange of expertise in the aforementioned sectors.

### SJC approves 2009 budget of judiciary

The Supreme Judicial Council (SJC) approved on Monday a budget of judiciary for coming year.

The budget will be used to set up a building of the Supreme Court and other judicial institutions.

The council, headed by Judge Isam al-Samawi, also approved plan of replacement for 270 judges and prosecutors in accordance with suggestion presented by minister of justice and general attorney.

Then, the council discussed a report on performance of the council and its achievements during the pervious period of the current year.

#### Cabinet agrees on STC's draft bylaw

The cabinet agreed, in its regular meeting held on Tuesday, on the draft law of the Supreme Tender Committee (STC) and directed concerned authorities to complete law measures required for its issuance.

The bylaw aims at enhancing STC's measures for protecting public fund, country processions, combating corruption in conducting tender and affirming justice and equality between contesters as well as controlling and naming measures and enhancing economic competence in tender process.

It also organizes the committee's meetings, mechanisms of issuing its

decisions, system building and its technical and administrative apparatus.

#### Cabinet agrees on Ministry of Industry and Trade's by law

In its meeting held on Tuesday, the cabinet agreed on the draft republican decree over Ministry of Industry and Trade's bylaw and directed concerned officials to complete law measures for issuing the decree.

The bylaw, that contains 58 items, organizes the ministry's activities, enhancing its efforts for realizing strategy of improving trade balance of the republic, enabling meddle and

small-sized facilities of competition, including Yemen's economy in regional and international economic alliances and realizing stable prices of basic goods.

The bylaw includes also making strategies and policies for developing industry, encouraging industrial investments and other aims for providing continuous environment to business sector.

#### Reducing unemployment rates high priority of government: al-Arhabi says

Minister of Planning and International Cooperation Abdul Karim al-Arhabi emphasized on Tuesday that the government's top priorities in the future are to reduce the unemployment rates and provide youths with job opportunities.

Al-Arhabi held talks with the Regional Director of the International Labor Organization (ILO) Beirut Bureau Nada al-Nashef on the general principles of the National Strategy for Employment.

The strategy aims to carry out several projects, activities and projects in order to reduce rates of unemployment and children labor besides improving workers' conditions.

The two officials also reviewed the strategy's executive plan and means of sustain its projects.

### Five republican decrees and a law issued

Two republican decrees No. 147/2008 and No.148/2008 were issued to

appoint Ahmed al-Himiari, assistant deputy governor of Dhamar and Nasar Amabd as head for Abyan

prosecution.

Moreover, a republican decree No.149/2008 was issued to appoint Yahya al-Shami as advisor for the ministry of endowments and guidance.

Other two decrees No.150/2008 and 151/2008 were issued to assign Mohammed Abdul-Salam Mansor as advisor for ministry of culture and Mohammed Hadi Salam as advisor for ministry of transport.

On the other hand, a Law No. 44/2008 was issued to approve a loan agreement signed between Yemen and Saudi Fund for Development last November, 2007 to finance a project of Central Hodeidah Hospital at sum of \$30 million.

### Social insurance foundation to apply work injury insurance

Chairman of Public Foundation for Social Insurance Ahmed Saif said on Tuesday that foundation is preparing to apply insurance of work injury during the few coming period.

Upon his departure to Syria, chairman Saif said that the aim of the visit is to get acquainted with Syrian experience in the field of insurance and work injury.

He added that visit comes to implement cooperation protocol which was signed between the Yemeni-Syrian Insurance Foundation during the meeting of 8th session of the Supreme Yemeni-Syrian Joint Committee held last May.

He expressed his wishes for outcomes of the visit to be successful at the level of exchanging experiences and expertise to improve insurance performance goals between the two countries.

### HCT says 119 tenders approved in first half of 2008

The Higher Committee for Tenders (HCT) approved 119 tenders during the first half of 2008, a report of the committee said.

According the new report, the cost of

these tenders was at YR 56 billion to set up development and services projects across the country.

Tenders were in fields of public works and consultative services, the report added.

Recently, the committee sent letters to all concerned authorities to comply with law of tenders No.23/2007.

### Evaluation workshop on YWU's elections began

Under the sponsorship of International Care Organization, Yemeni Women Union (YWU) began on Tuesday an evaluation workshop on the election process of the union 2008.

The two-day workshop aims at evaluating strength and weakness points of the union's election program 2008 aiming to improve skills.

In the workshop opening, the chairwoman of the union Ramziah al-Eryani affirmed the importance of increase the society awareness on women issues.

She made reference to the necessity to spread awareness among the Yemeni women on their elections right and their participation in the elections that would be held next year.

### Cabinet refers amendment draft of election law to parliament

The cabinet approved in its Tuesday meeting headed by prime minister Ali Mujawar referring an amendment draft of some articles of law No. 13 for 2003 over general elections and referendum to the parliament for finalizing its issuance.

The amendments come to avoid the shortcomings of the law appeared last period, reinforce guarantees to hold free elections and to benefit from the European Union's recommendations issued after the 2006 presidential elections in addition to adopting what the political parties agreed on.

The amendment draft included issues concerning fields of challenges and the right of challenges against the candidates of parliament and local elections during the nomination period.

It also enhanced the media neutrality during the election campaigns and the right of offering administrative com-

plaints during the elections processes as well as regulating the election's security and the right of monitoring election either local or foreign.

Governor of Hodeidah Ahmed al-Jabali held talks here on Tuesday with the member of the Supreme National Authority for Combating Corruption (SNACC) Mohammad al-Matari on aspects of maintaining the public fund.

The meeting discussed means of applying rules and regulations in the various sectors and executive offices in the governorate.

Al-Matari hailed the governorate's efforts to facilitate the SNACC's mission to discover the corruption and do whatever needs to uproot it.

Who are the excluded groups in the ESCWA region and what makes them so? What is Social Exclusion? How is it different from poverty? Who does it affect and why? Questions that UN-ESCWA and a quorum of regional experts, academics and activists will attempt to answer this week, on 1-2 August at an expert group meeting on "Social Exclusion in the ESCWA Region: Determinants and Indicators",

to be held at the UN House, Beirut.

Three UN-ESCWA countries,
Lebanon, Yemen and Egypt, have served
as research grounds for this topic. UNESCWA conducted 36 –in-depth interviews with men and women who live on
the margins unable to benefit from different opportunities and services.
Groups included refugees, street children, persons living with HIV/AIDS,
Magaber residents, and others.

Participants in the meeting will discuss the findings of -studies, UN-ESCWA's definition of social exclusion; and the research methodology required to capture social exclusion and to make it a useful and meaningful tool of analysis in the Western Asia region.

UN-ESCWA's work on social exclusion is part of the United Nations Development Account Project (UNDAP), "Interregional Cooperation to Strengthen Social Inclusion, Gender Equality and Health Promotion in the Millennium development Goals (MDGs)", initiated in 2006. Since the general targets of the MDGs do not adequately address certain disadvantaged groups in different societies, the project is intended to supplement the MDGs with specific targets and localized indicators that measure the determinants of the exclusion and which take into account the challenges and differences facing the different regions in their

progress towards the these millennium

# REAL-TIME TEXT AIMS TO IMPROVE INTERNET ACCESSIBILITY FOR THE DEAF AND

HARD OF HEARING
The blossoming of multimedia content on the Internet in recent years has revolutionised personal interactions, business communications, and other online services. But for millions of Internet users with sensory disabilities, many of the communication tools remain frustrat-

ingly out of their reach.

Mr Arnoud van Wijk, Disability Projects Coordinator for the Internet Society (ISOC), who was born deaf, knows only too well the frustration Internet users with a disability experience from many current Internet servic-

"During the past few years, the use of the Internet as a modern replacement for telephony has accelerated," said Mr van Wijk. "The ability to include more media in calls provides an excellent

opportunity to include people with disabilities in online conversational services. But too often discriminatory voice telephony services are simply recreated."

With this motivation, Mr van Wijk and other researchers have documented a technique for "real-time text"; combining existing Internet Engineering Task Force (IETF) standards to enable text streaming over Internet Protocol net-

The technique uses Internet telephony protocols to ensure compatibility with voice, video, and other multimedia services on the Internet. It allows text to be sent and received on a character by

character basis, with each character sent and displayed immediately once typed, giving text the same conversational character as voice communica-

tion.

According to Mr van Wijk, "Internet Telephony is rapidly becoming a major way of staying in touch. But it breaks the traditional text telephone, which deaf and hard of hearing people used in the past to call each other. The real-time text technique addresses this problem and can be integrated with Internet telepho-

ny."

Along with fellow technologist Guido Gybels, Director of New Technologies at RNID (UK), and with contributions from other experts in communication and accessibility for people with disabil-

van Wijk edited and co-authored 'Framework for Real-Time Text over IP Using the Session Initiation Protocol (SIP)', which the IETF has just published as an informational document in its 'Request for Comment' series as RFC

To further progress work in this field, this week sees the launch of the 'Real-Time Text task force' (R3TF), an informal forum for engineers, motivated individuals, experts, companies and organisations. The R3TF has received incubation support from ISOC, as part of its "Enabling Access" initiative, under which ISOC promotes a diverse range of projects aimed at breaking down the bar-

riers to Internet access.

Michael Burks, Chairman, and
Cynthia Waddell, Vice Chairman of
ISOC's Disability & Special Needs
Chapter, welcome the announcement of

the new task force.

"Accessibility for persons with disabilities is critical and must be maintained in the coming convergence," said Ms Waddell, an Accessibility Expert to the International Telecommunication Union (ITU), who is hard of hearing herself. "But it is worth pointing out that, like many disability projects, this effort has the potential to provide more options and greater usability for all users in many situations."

# New southern-based political movement stresses reconciliation, cooperation

bdulrahman Al-Sakkaf is one of the founding members of a movement called the Democratic Initiative for Change and Construction, which is applying to become a new Yemeni political party.

The movement started with a group of Yemenis from the southern governorates desiring to stress reconciliation and cooperation rather than silence and secession.

Al-Sakkaf, who is originally from Hadramout, sat down to explain the movement and its goals for Yemen's future.

# We first want to know about this Democratic Initiative for Change and Construction, so what is it?

The Democratic Initiative for Change and Construction is a burgeoning political party comprised from a broad national line-up representing all societal groups. Its members have a strong belief in freedom – which is based on democracy – equality in citizenship and social justice as necessities to achieving Yemeni peoples' aspirations to develop, prosper and have decent lives.

# So, is this a new party movement and if it's independent, does it have members from all parties and governorates?

The Democratic Initiative is an independent political organization comprised of Yemeni youths with experience in various fields, along with some who have attained high leadership positions both in the ruling and opposition parties. Our movement also includes several cultured writers and university professors, in addition to other important Yemenis from the revolution and unification generations in every governorate. These public figures in the movement's leadership include Dr. Murshid Shamsan, Ahmed Al-Shara'abi, Dr. Mohammed Al-Suroori and Dr. Hussein Bilal.

#### How many members are in the movement?

Our members – both men and women – who have been recruited into the Democratic Initiative number around 40,000 and is continually increasing. Once declared at our constituents conference to be held soon after we complete legal procedures according to the laws of the Parties Affairs Committee, this number will make it the third largest political party in Yemen after the General People's Congress and the Islah parties.

Our movement views democracy as the optimal way for the nation to get out of its successive predicaments and raise Yemeni society to guarantee freedom and equality. Such democracy also can move the wheels of development in order to achieve social, political and economic progress.

# Who is funding the movement, when was it formed and why is still in the establishment phase?

Concerning funding, the movement has decided not to rely on anyone – neither national nor foreign – for financial support, the reason being to protect the movement's decisions and initiatives from others' will. Instead, our movement depends on its members' personal efforts. For this reason, financial matters

have delayed our finding a permanent residence for the movement, forcing it to hold many of its meetings in hotel conference rooms.

The Yemeni government is supposed to provide whatever the multiparty system requires, as stipulated by the fifth article of the Yemeni Constitution, which states that the regime in the Republic of Yemen is based on a multiparty system.

The Democratic Initiative's introduction notes that Yemen currently is experiencing a conflict-of-interest crisis. Who is this conflict between – the Yemeni government and the opposition?

Talking about the correlation of conflict in order to attain power, our current political situation leads us to recall from our collective national memory the events and methods of Yemeni politics since revolution broke out in September and October 1962. Those events are considered the introduction and reasons for the deterioration of the political situation we're witness today as a result of those practices.

Following this revolution, upon which Yemenis relied to get out from under tyranny and the remnants of backward times, a civil war erupted in North Yemen that continued for many years. However, this conflict wasn't restricted to just the two warring sides – republicans and imamates – rather, there also were conflicts within the republican circle itself.

By the end of this civil war, the conflict for power extended to a series of military coups and this scene in North Yemen witnessed similarities in the south

All of these events wasted much time and effort, besides the huge damages they inflicted upon the nation and its citizens. Moreover, the revolution's morale began to vanish because the prospective project didn't see the light of day and the revolution's aims weren't achieved

There were conflicts on both sides of

Yemen, with the situation being aggravated and broadened in many forms due to continuous hindering of development projects. These various power conflicts were in the civil war between the two parts of the country.

With Yemeni unification came hope for a change for the better. However, the events since then haven't given much hope, as the same interactions returned in different forms to confirm that this way of dealing with things isn't the right one.

It's right that some within the opposition parties accept the government's stance on issues that don't serve the nation's supreme interests. Nevertheless, this coalition gathering the General People's Congress and the Islah Party to vote for the same presidential candidate, as well as the constitutional amendments in 1999, was reversed upon forming the Joint Meeting Parties.

Generally speaking, political relationships between the ruling and opposition parties are taking the abovementioned path of renewed conflict. This cycle of confusion won't end unless there's a real democracy based on the partnership of all peoples to get through the difficult situation and achieve future aspirations based on legal unanimity, which is one reason for establishing our movement.

#### Members of the ruling party created the current crisis in Sa'ada; the opposition had nothing to do with this war. In your opinion, what are the sides of conflict in Yemen?

Regarding the Sa'ada events, citizens know that the Houthi movement was no secret to the Yemeni government since it began. It's also clear that this movement has resorted to the memory of history and the geography of Sa'ada – the previous metropolis of the imamates – in order to reestablish long-gone regimes.

During the past four years, confrontations between the two sides have occurred repeatedly. While we don't know what the government will do during this period of truce, what the other side will do during this time is clear.

Some official practices may have had a role in agitating the last war. The picture may become clearer if we consider the explosions and assassinations that occurred prior to the war. Whatever side committed these disgraceful acts bears the responsibility for them and their consequences. Investigating those accountable for renewing this war is the government's task.

The Democratic Initiative desires to create a new Constitution, but what's the problem with the current one? What are its shortcomings, both in general and in detail, and will creating a new one solve these problems? As we know, since humankind began establishing ways to regulate society, regimes have been formed and developed over the course of time and throughout history. Philosophers worked a lot, particularly during the Golden Age, on the issue of society so that people would have their rights. Thus, this method specifies the form of the regime and the involved authorities, as well as regulates the relationships between those authorities.

Apart from a society's historical roots, its people are the natural source of a regime and its legislation. Therefore, it's necessary for all society members, including political parties, civil organizations and social leaders, to participate in and agree upon its Constitution. The development and construction process then begins to be supported by a unanimous legislative authority, which achieves the people's supreme interest.

When large segments of society don't participate or take part in issues, particularly if the issue concerns them as citizens, there will be rebellion against the regime and legislation is wasted. This is one of the problems with our current Constitution. There are many sensitive issues in this regard, such as the effects of the 1994 Civil War and the incessant fighting in Sa'ada.

Activities in the southern governorates are just one aspect indicating a crisis and a feeling that there's no justice and that others are deliberately marginalized. Thus, the tension now is between the government and the opposition, in addition to the violence that has begun there and includes confrontations between Houthis and the government.

There's a continuous need to save this nation from sliding into the unknown, but this can happen only through constructive dialogue and public partnership, which our initiative calls for, in addition to the government and all other stakeholders dealing with these issues earnestly.

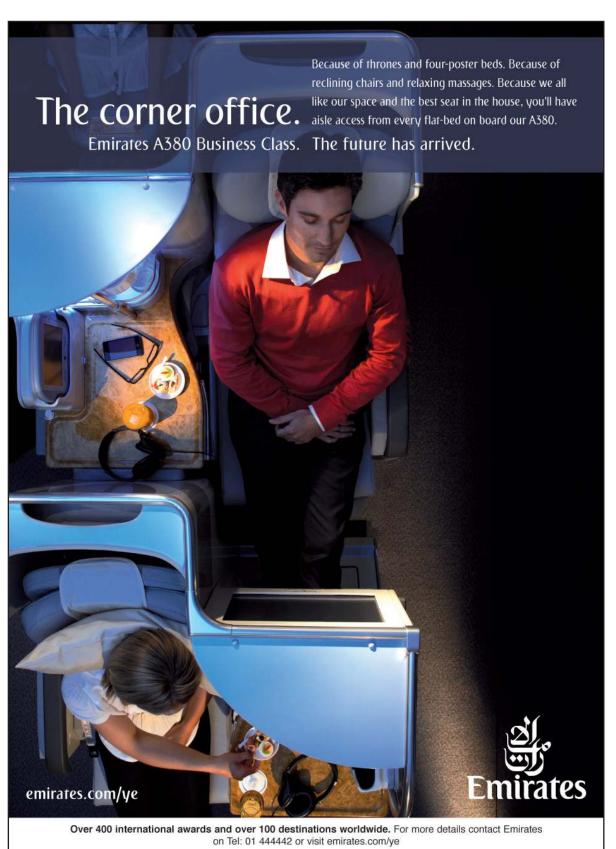
The Democratic Initiative is working to gather all current political parties, but some groups aren't represented by parties, although they are part of our nation. How do you suggest integrating Yemeni peoples' interests within the framework of reconciliation between the political parties?

Our initiative calls on political parties and all others to sit at the national dialogue table and participate objectively because the issue is related to the national and popular fate and applying the agreed-upon results. This doesn't contradict the independence of the political parties, but rather, strengthens their necessary roles.

Our initiative notes that the main bodies concerned are the ruling GPC and the JMP, but this doesn't mean others are excluded. Our initiative places national unity as its first aim, while stressing the participation of all social figures, intellectuals and political parties.

Further, we emphasize the importance of leaders' participation in order to move from the cycle of conflict to dialogue. All will benefit from this historical national project because the people are the owners of this interest because this matter concerns everyone.

Lastly, I want to reiterate that the Democratic Initiative is based on national unity and constructive partnership and it is from this idea that our initiative takes its name.

# I want my Al Jazeera

f you live in Israel, you can watch Al Jazeera English because its two largest cable systems, Yes TV and HOT Television, have bounced both CNN International and BBC World News in favor of Al Jazeera English.

If you live in Britain, you can also watch Al Jazeera English but you can't watch FOX News because in the eyes of the British regulatory watchdog, Fox has failed to meet the minimum requirement of regulatory licensing laws of objective and neutral news. However, if you live in the United States, you can't watch Al Jazeera because major American cable systems, including Time Warner Cable, Comcast and Fox Reality, have refused to carry Al Jazeera English.

#### **Townhall meeting**

If Americans want to watch Al Jazeera, they must buy a satellite dish from GlobeCast, a division of France Telecom. Toledo, Ohio, is one of the only two American cities that offers its residents the opportunity to watch Al Jazeera on their cable system, the other being Vermont's largest city, Burlington.

Recently, Al Jazeera English has been the center of a public debate in Burlington on whether it should stay in their city-owned cable system or be taken off the air. The residents that attended the public meeting were in a way the American jury deciding the fate of Al Jazeera for their town but symbolically for the United States. Al Jazeera understands the significance of this event, which explains why it was the main featured story of its media watch program, The Listening Post.

Al Jazeera English also sent two representatives to defend the television station: Al Jazeera English Managing Director Tony Burman and Josh Rushing, a former Marine spokesperson who served as a Marine Corps media liaison for 14 years before turning to Al Jazeera English. Rushing, who helped sell the war in Iraq to the American public as a Marine spokesperson, is now one of most effective spokesmen for Al Jazeera.

The controversy over Al Jazeera English started in May when Burlington Telecom's General Manager Chris Burns decided to drop the channel from the

municipally-owned telecommunications company due to the large number of complaints. However, Mayor Bob Kiss demanded that the channel not be pulled out until city residents had a chance to express their views.

Two separate forums were organized in late May and mid-June where citizens were given a platform to express their views about Al Jazeera English before Burlington Telecom's two oversight committees: the Telecommunications Advisory Committee and the Cable Advisory Council.

#### Heated debate

On June 26, Burlington Free Press.com reported that the two oversight committees jointly and unanimously recommended that the city-owned cable system maintain Al Jazeera English. In their recommendations, the committees said that much of the testimony against Al Jazeera English at the two heavily attended public forums seemed to have been "based on secondary sources," and that there was no evidence that the station condones terrorism, anti-Semitism or calls for the destruction of Israel. Such accusations were made by the Israel Center for Vermont and the Defenders Council of Vermont.

The public debates were very heated but in the process they brought to the surface a very important point. The Vermonters who defended Al Jazeera were not necessarily doing so only because they want to hear the Arab perspective on major world events, but rather because they saw Al Jazeera's award-winning news program as a viable alternative source of real news to mainstream television stations in the United States.

Rory O'Connor from Mediachannel.org told Al Jazeera English, "It is important to see the struggle that is going on now in Burlington as part of a larger struggle for media reform here in the United States, for voices, for more choices and for more diversity.

It is not that people want to subscribe to Al Jazeera English so they will follow, let us say, the politics of Al Jazeera English. They want to get other viewpoints and unfortunately there are not enough diverse viewpoints available on the American television airwayes."

Proud to be informed



Many citizens echoed this sentiment during the public debates.

One woman said, "I want to start by saying that I'm Jewish. In Israel, Al Jazeera English is one of the largest stations in the entire country. I sincerely hope that you think in terms of the freedom to listen to whatever is around."

Another woman said, "I kind of take pride that Burlington is one of the only American cities that has Al Jazeera and that is because we stand for freedom. We stand for an informed public."

Unlike most Americans, Vermonters who can watch Al Jazeera English in Burlington's cable system have come to appreciate the value of getting diverse

Al Jazeera, which has 70 bureaus and now reaches the homes of more than 110 million people worldwide, has beaten entrances by BBC News, Sky News, Lisboa TV and the Phoenix Satellite Television Co., and won the award for "Best 24 Hour News Program" at the prestigious 48th Monte Carlo Television Festival on June 14, 2008.

Tony Birtley's "Inside Myanmar - The Crackdown" won Best News Documentary and James Bays' "Taliban Embedded" was awarded a second place in the category of Best TV Item.

The Best 24 Hour News Program award is a testimony that English Al Jazeera is setting a higher standard for global news, in the same way that Al Jazeera Arabic service has set a higher standard for news in the Middle East.

#### Everywoman

If Al Jazeera beat BBC and Sky News, then U.S. channels like Fox and CNN simply do not have a chance. If Al Jazeera English was shown in America, these channels would have to provide more in-depth coverage, and depend less on local or embedded journalists.

Al Jazeera also has proven to be a serious competitor to public broadcast service channels in the United States by providing in-depth reports about different parts of the United States. One episode of a program called "Inside U.S.A" talked about gentrification in Harlem, New York, bringing attention to the plight of African-Americas who are being uprooted from their homes and stores to make space for more well to do tenants from [Manhattan.]

Another episode of a program called Everywoman focused on the plight of U.S. ex-servicewomen fighting against health care bureaucracy, unemployment, and high housing costs.

Most importantly, Al Jazeera English offers a wide variety of global programs bridging the gap between people of different countries, religions and cultures. As an example, Everywoman programs often juxtapose the plight of women from different cultures, religions and nationalities

One episode juxtaposed the plight of American Muslim sorority sisters with the plight of beauty pageant contestants competing for the title of Ms. Senior America. Other episodes showed American cowgirls competing, riding rodeo bulls, and Muslim women competing in soccer and car racing games.

What is unique about these reports is the fact that they are made by reporters on the ground who are familiar with the areas they are reporting on.

#### Six to one in favor of Al Jazeera

In one episode of Everywoman, the Israeli reporter Shira Livi tells the story of a 28-year-old Bedouin woman Sara who lost custody of her seven children to her drug addict husband. Sara picked Livi, who is a Jewish Israeli reporter, to tell her story and she told it in Hebrew, not Arabic. Livi was able to capture the complexity of the challenges facing an Arab woman living inside a tribal society in the heart of Israel.

Regardless of any perceived notions one may have about Al Jazeera, if Americans are given an opportunity to watch Al Jazeera English like Vermonters in Burlington were, they will most likely respond positively.

Sandra Baird, a lawyer and university professor, told Al Jazeera English, "At those public hearings [in Burlington] one noticed that the people that came out were hugely in favor of Al Jazeera. I counted the speakers the other night. It

was six to one in favor of Al Jazeera."

According to Tony Burman, former editor in chief of the Canadian Broadcasting Company (CBC) and now the managing director of Al Jazeera English, the station's website gets around six million hits a week worldwide, and more than 60 percent of these hits come from the United States. Burman added that "a lot of Al Jazeera's negotiations that are going on now are going quite well." He attributed this to the fact that the television station is becoming better known among cable distributors.

The Burlington Telecom's two oversight committees support Burman's view. In their recommendations, they noted that in the two heavily attended public forums they "witnessed a compelling preponderance of subscribers and potential subscribers requesting that BT not drop Al Jazeera English."

# "Citizen journalists are playing a big role in the Arab world"

"Citizen journalists report on how the world really is," says Sashi Kumar, Chairman of the Media Development Foundation at the Asian College of Journalism in India. Kumar, along with Nahla Al Shahhal, a freelance journalist contributing to the Al Hayat daily in Lebanon; Ayman Al-Sayyad, editor-inchief of Egypt's Weghat Nazar magazine; and Jihad Al Khazen, a columnist for the Al Hayat daily in London, spoke with APN about the swell of citizen journalism in the Arab world.

1 Shahhal, Kumar, Al-Sayyad and Al Khazen participated as panellists at the Arab Media Forum 2008. In their respective panels, titled "Freedom - the new battle-front for Arab cyber media," "Pushing Technology Boundaries," and "Are Transformations Breaking the Traditional Mould of Arab Media?" they discussed how technology has resulted in a surge of citizen journalism in the Arab world.

#### What exactly is citizen journalism? Kumar explains that the term implies the

Kumar explains that the term implies that "the function of news making belongs to the public sphere." Al-Sayyad elaborates further, clarifying that citizen journalists "are members of the general public who provide news materials, albeit outside the framework of professional journalism, such as bloggers or the public (eye witnesses) who provide pictures or video footage of incidents in the areas in which they live."

Citizen journalism is flourishing in the Arab world today where, as Al Khazen pointed out, the "trend is toward independent newspapers and electronic press. Arab countries are now allowing for independent and privately owned media." Access to the Internet has expanded rapidly throughout the new millennium and many active citizens have seized the opportunity to use technology to their advantage; giving the world a different taste of how life is in their region than the mainstream publications are providing.

"They have more compassion and understanding of the current events they're experiencing [than professional journalists]," Kumar tells APN.

The increase in Arab consumers using

the Internet has spurred many governments to limit access and broaden their control over the technology. Khazen spoke at the Arab Media Forum of the restrictions on mainstream media but clarifies to APN that "citizen journalists have far less restrictions."

"They must be doing a good job too because they're annoying Arab governments," Al Khazen jests. "They cannot control the blogs."

Despite controls and limitations that some Arab states have tried to place on the Internet, freelance journalists Al Shahhal boasts that the Arab world has the highest percentage of bloggers and citizen journalists in the world. Touching upon the influence of citizen journalists, she proceeds to say that it was the expansive network of bloggers in the country that orchestrated the general strike that swept Egypt on 6 April. "They told people to stay at home that day," she explained. "It gives you an idea of the power of bloggers."

Since the bloggers initiated the general strike they have also adopted the responsibility of reporting on it. "The recent labour strikes in Egypt have not been covered except by the bloggers who happened to be there in large numbers," says Al-Sayyad, of Egypt's Weghat Nazar

"Citizen journalists are playing a big role in the Arab world," Kumar stated. Particularly in areas of the region that are currently unstable, Kumar emphasized the importance of citizen journalists, not only to disseminate the news through

their own methods - be it blogs, mobile networks or newsletters - but also to give professional journalists stationed in the area a "real idea of what is happening on the ground."

"Professional journalists can't really report from the five-star hotels they're kept in," Kumar mused. "Citizen journalists report on how the world really is."

While speaking at the Arab Media Forum, Kumar had brazenly stated that "truth is only coming through citizen journalism;" a statement that he qualifies to APN by explaining that, in the Arab world, "professional journalism is artificial and stagnated - there is no free media in the Gulf." He continues to clarify that the emergence of citizen journalism is countering the "pre-emptive censorship and sins of omission" of professional journalists in the region. "Professional journalism is being challenged; there is a paradigm-shift taking place. The people are now able to speak to power with modern technology."

Al Shahhal does not entirely agree with Kumar's suggestion that citizen journalists are the sole harbingers of truth in the region. "There are newspapers with a large margin of independence and freedom," she says, naming the relatively young Al Akhbar daily in Beirut and the Al Masri Al Youm daily in Egypt as two examples. The website of the former has become one of the most popular online Arab news sources since its establishment less than two years ago. Despite these examples of liberty Al Shahhal does admit to there being "many taboos and red lines."

Where the two do agree is on the necessity for a free web. Speaking of the importance of the Internet, Kumar says that the web should be free and open. "It's the best approximation we have to a public sphere; open irrespective of creed or

# Who will be wanted after Al-Bashir?

egular readers of writings and dialogues on the website with regard to the international arrest memorandum expected to be released against Sudanese leader Omar Al-Bashir will get surprised by the fact that Yemeni websites in or outside Yemen are not less cheerful than the Sudanese in terms of commenting on the ordeal faced by the Sudanese President and his rule.

Cheerful Yemenis never care about Al-Bashir, nor do they care about what has happened in Darfur or what is happening in the south or east of Sudan. In fact, they are concerned about crimes of the ongoing war in north Yemen, as well as potential war crimes in south Yemen. They fear that this sort of crimes may lead to releasing an international memorandum to cappolitical and military powers, but give orders to troops to devastate villages and annihilate women and children.

This will not happen in Yemen in the prospective future due to the following

First: The multiple internal events in Yemen and the approaching date for change from within the regime will not give the relevant international forces enough time to pave the way for international public opinion to issue an arrest memo against a legally elected statesman, according to the testimony of international powers. This may work if the statesman retains his post until the international forces learn about what he commits against his people.

Second: The Yemeni regime succeeded in imposing a complete information blackout on what has been happening in Sa'ada by preventing media personnel, be they local or foreign reporters, from approaching the governorate. On the contrary, Houthis failed to use modern video cameras to take pure photos for events that may help condemn the regime at the international level, particularly as it orders service troops to destroy citizens' homes and property, and kill women and children

Although the available photo is of bad quality, Houthis' media instrument has focused on the destruction of tanks and burning of armored vehicles in a way priding themselves in lieu of delivering more important facts (photos for genocides) to the international public opinion.

Third: With regard to the South Part of Yemen, it seems that the regime began covering crimes committed against citizens like it did on July 7 when it held a street vendor with the military rank of a major accountable for the killing of several protesters in Aden with the intention of achieving two important objectives. Objective one is to deliver a message of intimidation to citizens of this part with the content: "Those who joint protests will not escape live bullets.

Objective two is to acquit the authority of flagrant crimes it has so far committed against citizens in South Yemen. The street vendor, however, was labeled as a criminal because he fired randomly in the air when policemen hunted him. He did so in order to avoid killing any of the protesters, particularly as he is one of

Fourth: Weakness of Yemeni opposition abroad, as well as its need for the capacity to fund and recruit pressure groups to promote such a Yemeni issue in the west, and highlight human rights abuses and genocides. This pressure is attributed to notable control of the individual work and loss of trust among opposition leaders abroad, which is why they have become unable even to exploit photos published on www.youtube.com that will raise various questions if they are not adequate evidence to condemn

Fifth: Regarding the available evidence against Sudanese President Omar Al-Bashir in person and members of the security cell affiliated with his regime, one can say that this evidence is strong, according to information obtained from Sudanese sources. This information is supported by documented sound and photos while other information is contained in tapes (footage without sound) leaked from the State's television during Al-Bashir's meeting with top loyal officials in his government.

Television staff may leak video tapes and deliver them to the International Court. In Yemen, the available evidence may help in uncovering corruption cases, killing or assassination, however, they don't suffice to accuse the regime of committing mass massacres. And, when available, such evidence in Yemen doesn't go beyond the limit of personal notifications taken from leaders involved in

Regional and international forces often favor that these leaders remain in their positions since they constitute a precious source for information instead of losing them for the sake of prosecuting the top political leader in the state.

Sixth: Irrespective of the availability or lack of evidence, the primary motive for provoking an issue against members of the Yemeni regime still is absent. It is represented by the desire of world superpowers to topple the regime because prosecuting the top leader in the regime will eventually mean complete fall of the regime. Even if there is an international will to oust the standing fragile regime in our country, there are other means, which are more quick and feasible than waging a legal war due to last up for many years before the international community realizes its outcome.

#### Yemen opposition not effective:

Clearly, the Yemeni opposition's inability to crystallize an alternative to assure people about their future, and at the same time assure regional and international forces that their interests will remain in safety, still reflects the primary obstacle before sought-after change. In addition, this inability supplies the standing regime with the sort of ammunition it utilizes to fight against its opponents via making the international community fear them.

In conclusion, those, who pin a great hope in the international community or the International Justice Court to insert Yemeni President in the list of leaders wanted by the U.S. Administration for prosecution after the Sudanese leader was added to the list, should wait for a long time period. The best thing for them to do is contemplate on the famous proverb saying, "Nothing may rub your skin like your fingernail does." This is a completed agenda with hast revenue and content in total contrast to an international court subjugated by interests of superpowers that have not even signed the agreement under which the court was established.

# Three decades of Saleh's pragmatism and tribalism

.E. President of the Republic Abdullah marked this monh the 30th anniversary of his presidency that meets the 17th of July. Throughout his three decades of leadership Yemen has witnessed several upheavals. His leadership has great influence on the country's politics over the past 30 years and will continue to have impacts on the Yemeni political landscape for several years ahead.

The main characteristics that have featured president Saleh's reign can be boiled into: Pragmatism and Tribalism. In fact, it was his tribal oriented character that propelled him into the helm of power, on 17th of July 1978. Driven by his tribal sense and motives, the junior lieutenant had initiated to undertake the leadership to avenge his president Ahmed Al-Ghashmy 's assassination that said to be president Salim Rabee'a of the southern part of the country was blamed for.

Then, Saleh had come to power with a retaliatory agenda, at least at that moment, and not with a visionary political and economic platform. Yet, he was really too brave and adventurer to assume the office at that turbulent time, notwithstanding his primary real motivation, whether to lead the country to the safe anchor or to carry out his reprisal. Many of his colleagues and fellows suspected that he would face the fate of his predecessors, not long time later.

The young ambitious commander of Taiz-brigade, with no career as a politician and not to mention the lack of academic studies of statecraft, had managed to command the approval of the General Assembly to steer the ship. Soon, he had proven out to a man of great potential as a pragmatic leader. He had already learned the rules of the game very quicklyparticularly, in the area of security.

How has he managed to hold on the top job for three decades? It can be said with quite certainty that he has been very pragmatic at both domestic and regional levels. He has never had a permanent foe or ally, neither locally nor regionally. He has been ready to make concessions, to accept half-way solutions and to forge temporary coalitions as well as to reach a compromise as long as that serve his own policy and doesn't target his own power.

He has opted for an appeasement and reconciliatory approach to contain the potential opposition groups. He had begun with forging an inextricable link with the main influential tribal figures around the country, most important of all the late Sheikh Abdullah Bin Hussein Al-Ahamer. Then, he had pursued an active cooperation with the Islamist groups to fight the Yemeni Socialist Party (YSP). After that he had created the General People Congress (GPC) to include: leading politicians of all political stripes, social dignitaries and prominent sheiks.

Not long time later, he seemed as if he had come to power to carry out a specific regional and international agenda, to counter the socialism in southern part of Arabian Peninsula. To this end, he had been offered all required resources. Yemen was the largest recipient for direct and indirect financial assistance from the Gulf states, in the 1980s

In exchange, the regime in Sana'a under president Saleh had devoted its security and intelligence capacities to crack down pro-Aden regime of socialist and secularist oriented politicians and intellectuals. The generations younger overwhelmingly exposed to an aggressive anti-socialism, and secularism communism campaign all the time, in schools, mosques and media. Religious scholars, preachers and teachers were given a free hand to attack (YSP) and preach intensively the Wahhbi-style of Islamic attitudes. That was really a blunder as it has started to backfire seriously.

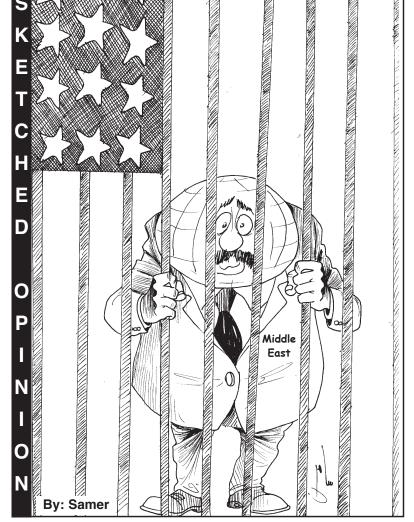
His pragmatism had actually helped him to deal reasonably with the regional and international powers. In the first decade of his presidency, his pragmatic manner enabled him to effectively manipulate the political forces in the domestic scene, thus to bring a relative political and economic stability in the north of the country, thanks to the generous financial support of the Gulf nations. To his great credit, his pragmatism had already played a key role in Yemen's re-union. This great achievement, indeed, covers all defects that might be a by-product of his pragmatic approach and policy.

The bad news, is that both his tribalism and pragmatism were counterproductive. Since the early years of the second decade of his ruling, his tribal-style leadership has been causing huge damage to the country's economy, stability and image. While pragmatism in politics is a norm, tribalism is lethal. Remember, when Saddam Hussein invaded Kuwait, Yemeni leadership led by president Saleh had acted tribally. That tribal reaction to that Arab catastrophe had nothing to do with politics, in deed, Saleh was given in to his tribal sense rather than his proven pragmatism. That uncalculated maneuver had opened pondera -box for Yemenis who had to pay high price for his tribal

Tribalism has been steadily and increasingly promoted under president Saleh. Today sheikhs and tribal figures yield much more intellectuals, influence than politicians and community leaders. His 30 years leadership has largely tribalised the state's institutions in terms of manners of leadership, management and function. This can be seen clearly in the Parliament. He also has inspired great deal of tribal oriented actions, such as vengeance and kidnapping, to mention few.

In short, his pragmatism has largely enabled him to put northern local opposition under control in 1980s, to defeat southern rivals in 1990s, to do away with his partners in the early years of the recent decade. Meanwhile, his tribalism has undermined pragmatism. Hence, has constantly failed to build an institutionalized state, enforce the rule of law and bring up good governance.

# Is Yemen at its stability tipping point?

t often takes a crisis to rivet our collective attention on problems such as those facing Yemen, a society that seems to be perpetually on the verge of collapse. While it is difficult to tease apart fact and fiction when dealing with Yemen, the country has real problems that need attention from key international players, especially the United States and Saudi Arabia.

Over the past six months, the tone in international media coverage of Yemen has become increasingly apocalyptic. On the security front, the resurgence of Al-Qaeda in Yemen has been well documented via a spate of brazen attacks, leading security experts to warn that the new generation of Yemeni militants will be more lethal than its predecessors.

The failed state narrative, in which Yemen devolves into something resembling Somalia or Afghanistan, has also spread. Yemeni ministers, foreign aid workers, and journalists routinely predict an imminent demise, as food prices skyrocket, drought hurts harvests, the long-running Al-Houthi rebellion in the north drags on, and riots erupt in the south over unresolved grievances stemming from the 1990 reunification of the

At the same time scholars (as opposed to journalists and other visitors) reflexively repudiate the idea that Yemen is on the brink of disaster. asserting that President Ali Abdullah Saleh operates in an environment of controlled chaos. Instability, critics allege, is manufactured to garner international sympathy - and external

The old formula for power that made the controlled chaos scenario viable, however, may be changing. The December 2007 death of Sheikh Abdullah Hussein al-Ahmar, a key power-broker and interlocutor between Saleh and the tribal wing of the opposition Islah party, leaves a political void that Yemeni Salafists may attempt to fill. The 2009 parliamentary elections will be a key test in this regard. Presidential succession also clouds Yemen's future. Saleh's term ends in 2013, and the line of possible successors is growing, particularly from within his own extended family.

Among the leading contenders are his son Ahmad and Saleh's halfbrother, Brigadier General Ali Mohsen al-Ahmar, the Commander of the Northwestern Military Flank and an alleged Salafist sympathizer.

Civil society activists and international observers point to signs that the twin pressures of insecurity

and economic stagnation have overwhelmed the authorities and led to curtailment of political freedoms. In June, a state security court sentenced noted independent iournalist Abdulkarim al-Khaiwani to six years in prison on a charge of collaborating with Al-Houthi insurgents. Observers believe that the regime targeted Khaiwani for his investigative reporting on the revolt. While in prison, he received an award from Amnesty International for his

Yemen's systemic challenges certainly are real and must be taken seriously. Oil production is dropping rapidly and, despite the government's insistence that new fields will be discovered, many promising areas already have been explored. Yemen also has one of the greatest water shortages worldwide.

To keep pace with population growth, Yemen requires a massive infusion of cash and energy to finance and fuel several costly desalination

And yet something more than mere alarmism about Yemen's predicament is needed. Unfortunately, the key international players - the United States, Saudi Arabia, and other Gulf Cooperation Council (GCC) countries have been unable to formulate a collective long term strategy to save Yemen from itself. There seems to be no real consensus among the outside powers about whether Yemen faces a heightened risk of instability now and what the consequences of such instability would be.

An ongoing misunderstanding between Yemen and the US about counter-terrorism efforts is a major problem. For nearly a year, US relations with Yemen have been deadlocked over the fate of Jamal al-Badawi, a ringleader in the 2000 USS Cole bombing who was released from prison after swearing allegiance to Saleh and pledging to cooperate against Al-Qaeda.

Critics charge that the government is protecting Badawi, among others, despite repeated US demands for his extradition. Yemen refuses to cave in to American pressure, citing a constitutional ban (Article 44) on extraditing Yemeni citizens to foreign entities, while insisting that the nearly 100 Yemeni prisoners detained in Guantanamo Bay, Cuba, be returned to Yemen for "reintegration." US policymakers not only resent Yemen's obstinacy, but feel a visceral sense of injustice knowing that operatives such as Badawi remain at large.

For his part, in a June 2008 New York Times interview, the Yemeni president called the United States "arrogant" for demanding that he sever ties with known Al-Qaeda supporters.

The Badawi stalemate, coupled with growing US concern about security and political conditions in Yemen, has gone well beyond a war of words to put the entire bilateral relationship into the deep freeze.

Millennium Challenge The Corporation's \$20.6 million threshold program - which was to help Yemen meet standards required for a much larger package of economic development assistance suspended. Rocket attacks in spring 2008 on or near compounds where US officials lived, caused the US Embassy in Sanaa to evacuate all non-essential personnel.

And after Khaiwani was sentenced, the US Department of State publicly rebuked the regime, stating that his imprisonment "points to a distressing trend in Yemen of intimidation and prosecution." For Washington, it continues to be difficult to craft an overall policy approach toward Yemen that disaggregates security issues from humanitarian and democratization concerns

When it comes to Saudi Arabia and the GCC, Yemeni officials use the specter of Iranian meddling in the Al-Houthi conflict to seek support from their Saudi neighbors, who are alarmed by a Shiite insurgency on

Although the Saudis have increased both their political and financial support for Yemen in recent years, the rest of the GCC has not been as forthcoming, feeling no real sense of urgency to accelerate Yemen's bid for GCC membership. Furthermore, it is doubtful whether the conditionality attached to Saudi and GCC money will mirror US and Western reform

The tipping point for Yemeni stability may be approaching, although it also is quite possible that in the years ahead Yemen will muddle through as a ward of Saudi Arabia and the GCC. Either way, who is paying attention? Until its problems spread, a sustainable policy toward Yemen will continue to be caught between crisis and complacency.

# Serious negotiations or hot confrontation with Iran?

or two weeks, it looked like the regime in Iran had finally gotten the message that, if it continues to pursue its nuclear program, serious military confrontation is likely to result. Indeed, there were interesting - and previously unheard of - statements and signals from Teheran that suggested an increased willingness to start negotiating about Iran's nuclear program and regional security issues. And America's decision to send Undersecretary of State William Burns to a meeting with Iran's top nuclear negotiator suggests that those signals are being taken seriously.

But the recent military muscleflexing with rocket tests and the rejection of a compromise by Iranian President Mahmoud Ahmedinejad and his foreign minister show that the country's leadership is seriously divided over the strategic line that Iran should pursue.

Iran's leadership still harbors the misconception that Israeli threats against its nuclear facilities are an expression of the domestic difficulties of Prime Minister Ehud Olmert's government. This is plainly wrong. Olmert's government has serious problems, but they are not the reason that the situation between Israel and Iran is coming to a head.

On the contrary, a cross-party consensus exists in Israel concerning Iran's possible nuclear armament and regional hegemony. All sides agree that, unless there is a diplomatic solution, Iran's possession of nuclear weapons must be prevented in good time and by any means necessary. Moreover, Saudi Arabia and some other Arab countries share this view, albeit behind closed doors.

If Iran adopts a more realistic approach, there is real hope for a diplomatic solution. The most recent offer of the 5+1 group (the United Nations Security Council's five permanent members and Germany) was well received in Teheran. In addition to far-reaching political and economic cooperation, the offer promises cooperation on nuclear matters, including the construction address regional security issues (Iraq, and supply of the newest light-water the Israeli-Palestinian conflict, Ahmadinejad came to power. But is

access to nuclear research and development – provided that there is a negotiated settlement.

But what was really new is that Iran also responded positively to the procedure proposed by the 5+1 group. In the pre-negotiation phase, this means that Iran would agree not to install any new centrifuges, necessary for increasing the volume of uranium being enriched, while the 5+1 group would refrain from calling for new sanctions in the Security Council.

Once negotiations start, Iran would, under the supervision of the International Atomic Energy Agency, suspend its uranium enrichment and all related activities for six months something that the Iranian government refused even to discuss in the last four years. For its part, the Security Council would suspend all its deliberations related to the Iranian nuclear program.

The aim of these negotiations is a comprehensive agreement between Iran and the 5+1 group that would resolve both the nuclear conflict and

while opening extensive international and regional cooperation.

There were also signals emanating from Iran that, having, having mastered uranium enrichment technology, the authorities could envisage continuing enrichment in a third country in a joint consortium with the West. A similar proposal made by Russia was unceremoniously dismissed only a short time ago.

Moreover, while there is no willingness to accept Israeli hegemony, the tone vis-à-vis Israel is beginning to change. Ahmadinejad's vile anti-Semitism has of late been indirectly, but fairly openly, criticized by one of the closest confidants of Iran's supreme religious leader, former Foreign Minister Ali Akbar Velavati, Iranian spokesmen also indicate that there is an official awareness of Israel's importance for a comprehensive regional solution, and that doing business with Israel is no longer inconceivable.

One hasn't heard this sort of language in all the years since

simply the old stonewalling tactics? Does the government just want to buy time once more, now to make it through the America's presidential elections? Given the public contradictions in the Iranian leadership's behavior, is there a reliable Iranian position, and, if so, who represents it? These crucial questions can only be answered by the practical test of negotiations, this with direct American time participation.

If Iran is serious, the result may be nothing less than the long awaited "Grand Bargain" – a regional reconciliation of interests between Iran, on one side, and America, Europe, and the region's US allies on

But if Iran is playing for time, its behavior is shortsighted and foolish. The conflict, and thus the danger of a military confrontation, will not disappear under a new US administration. On the contrary, should the negotiations fail, the confrontation will resurface in short order, and be far more dangerous.

the current American administration on the question of Iran's regional hegemony and its nuclear program. Indeed, if a diplomatic solution fails, they are more likely to react more forcefully. It is therefore imperative that diplomacy, which looks possible at the moment, be given a chance.

If the top leadership in Teheran has realized that it makes a great deal more sense, and is more in keeping with Iran's interests, to consolidate the successes of its foreign policy in the last few years, and to strengthen the regime, rather than risk everything in a military showdown with unforeseeable consequences, then there is a real chance for a diplomatic solution. If not, the region will be plunged into a hot confrontation.

There's wisdom, which Iran's leaders should heed, in the old adage that a bird in the hand is worth two in the bush.

# Islamic Army in Iraq

'n a recent interview with The Media Line, The Islamic Army in Iraq (IAI), a prominent Sunni insurgency group, revealed its motivations, ideology and aims regarding the war in

Among the main issues brought up during the interview with IAI spokesman 'Ali A-Na'imi, were the following:

Established after the fall of Saddam Hussein's regime in 2003, the IAI is comprised of ex-Iraqi military officers, all - or most - of whom are adherents of the Sunni creed. These officers recruit young Sunnis to the organization and train them in a combination of military disci-

The movement takes the media war seriously and uses the Internet to promulgate its ideology. It produces a monthly magazine and airs a daily updated website. Each month the organization publishes what it calls the "harvest" of its operations. During last month, the IAI managed, according to its website, to kill at least 28 American soldiers, using guns and bombs. Following are excerpts from the interview:

By: Yaniv Berman The Media Line

**TML:** Most parties in Iraq are backed by a military arm. In an ideal democracy, do you believe parties should have a military arm?

IAI: Democracy is a great illusion used by the U.S. to deceive the peoples [of the world] in order to justify its criminal deeds. It is an impossible concept in light of an occupation, which employs a divideand-rule policy.

TML: In the past, the IAI said it considered [conducting] negotiations with the American army. What is your stand regarding negotiations today?

**IAI:** Our door is open to negotiations with others, for it is an important principle in war according to Islam. The religion of Islam permitted this principle in order to save lives and turn to war only as a last resort. Islam is a religion of peace and the Muslim only fights if he has to, as is our situation in Iraq. The Islamic Army's official spokesman has announced our readiness for negotiations with

preconditions. These include an rights we [are willing to] die for and announcement by the U.S. Congress regarding a timetable for the American forces' withdrawal from Iraq, and its recognition in the TML: You recently said that during resistance as the Iraqi people's legitimate representative. However, until now we have not seen any serious steps from the Americans toward negotiations.

TML: Your activities involve much killing. How does this affect your warriors from a psychological point of view? Do they ever seek any psychological or other kinds of aid?

we believe in the hereafter. Fighting in the name of Allah is a divine honor and grace our warriors not only contend for but also take pleasure in. Therefore, they suffer no psychological effects or any such problem, contrary to the occupation soldiers' pangs of conscience and fears of death and disability, which they suffer for the sake of satisfying [U.S. President George W.] Bush's vanities. # Giving Yemeni youth a "Third Option"

The Small and Micro- Enterprise Promotion Service, an agency of the Social Fund for Development, has managed to convince the Ministry of Technical Education and Vocational Training to introduce a new subject called "Know About Business" – or KAB for short – in order to encourage a sense of entrepreneurship among Yemeni youth and provide them with skills to start their own businesses instead of relying on jobs in the public sectors.

ameer is the middle child of seven children and the only one without a university degree. However, he is the most successful among them because he started his own business selling electronic goods and computer maintenance services in Taiz.

"Seeing how successful our brother is, we realized that a university degree or a job with the government is not the best thing," commented Sameer's brother, Ahmed.

There is a common understanding among Yemenis that getting a stable income is better than launching a pri-

vate business that would include risk.

"The problem is in the attitude,"
explained Alawi Mohammed A.

Bafaqih, the Vice Minister of Technical

Education and Vocational Training. He

thinks that Yemeni youth need to rediscover the so-called "third option," whereby they need not be dependent on either the government or the private sector for employment.

"The problem is that the society looks down upon graduates from the technical and vocational institutes," said Bafaqih. "Even the private sector does not encourage these graduates and so the only people who opt for such technical education are the ones who were not accepted anywhere else."

Realizing this issue, the Small and Micro-Enterprise Promotion Service (SMEPS) sent Ahmed Abdulbary Ali, a project officer at SMEPS, to learn about a new program to help vocational trainers encourage their students to start businesses at the International Labor Organization's (ILO) training center in Turin, Italy.

"Once we had enough evidence that this would prove useful for Yemeni youth, we held a workshop with stake holders and presented this training idea to them," said Wisam Al-Ariqi, the Director of SMEPS. "At the time, they all seemed enthusiastic about the idea, but so far only the Ministry of Technical Education and Vocational Training has taken serious steps to introduce KAB into Yemeni education."

The interesting aspect of this training, as Al-Ariqi explained, is that it is entertaining. It is like one of those money-oriented board games where the players have to create a strategy, think about their risks, work hard to defeat the competition and make a profit. "Which is what business in real life is all about," said Al-Ariqi.

A third option KAB's general objective is to con-

tribute towards the creation of an enterprise culture in a country or society by promoting awareness among young people about the opportunities and challenges of entrepreneurship and self-employment. It aims to show young people their role in shaping their future and that of their country's economic and social development.

Last year there were 240,000 graduates from government universities in Yemen, compared to only 24,000 technical and vocational training graduates. With a ration of 1:10 there is an overwhelming majority of university graduates who specialized in disciplines such as literature or history, and who want desk jobs but don't have any particularly marketable skills. Dr. Ibrahim Omar Hugari, the Minister of Technical Education and Vocational Training, promised that the number of technical education institutes, currently 64 vocational institutes and 35 community colleges, is going to increase soon. He explained that 50 more will be established in the next few years, 18 of which are funded by the Kingdom of Saudi Arabia.

Products of these institutes and community colleges will supply the job market inside and outside Yemen with urgently required skilled labor. He hoped that this way, the balance between academic and technical education will be restored and hence the dynamic of the Yemeni economy will improve.

"It is impossible to create businessmen and businesswomen in one year. What we hope to do is to encourage such thinking and lay the fundamental skills for youth so that they build on this in real life, where they would be on their own," explained Ali.

Ali Hamoud Taher, the General Director of Curricula and Educational Media, agreed with Ali and hoped that the trainees would create networks and business groups whereby they can work together on small business ventures in order to minimize the risk and maximize their learning experience.

To start with, 56 teachers who had business experience will be trained on how to teach this subject in the vocational institutes. Then the students will be given an aptitude questionnaire at the beginning of the academic year and again at the end of the year to monitor

any aptitude changes in business and managing small enterprises. During the academic year, experts from SMEPS, the ILO and the Ministry of Technical Education will evaluate the training in all the institutes and provide feedback to the Social Fund for Development on the success and the progress of the program. At the end of the year, the students must be able to create a simple business plan in which they should apply the lessons from the course.

However, the real success of the training will be realized only after three or four years when the students graduate and start their own business or not.

According to Taher, the ministry has an electronic database system to track the graduates and their careers in order to see to what extent they have developed entrepreneur skills or attitudes.

#### Know About Business

KAB training aims to firstly develop positive attitudes towards enterprises and self-employment among the population by targeting youth but also stakeholders for enterprise development. Secondly, KAB provides knowledge and practice of the desirable attributes for and challenges in starting and operating a successful enterprise. This means that the curriculum provokes business oriented thinking and equips the trainees with ideas and skills to start their own business venture.

The KAB package is designed to provide teachers and trainers with the materials necessary for a 120-hour course. It comprises a trainer handbook and nine modules. Each module represents a key area of entrepreneurship and each is divided into several topics.

In Yemen, the course is to be studied throughout the first year of the vocational training education instead of a subject called project management. The titles of the modules are in the form of questions, which the trainees should be able to answer after the completion of the module.

Module 1. What is Enterprise? The module's objectives are to enable learners to recognize that everybody is involved in an enterprise in one way or another. It enables learners to appreciate that everybody's lifestyle is affected by the roles they play in their enterprises.

Module 2. Why Entrepreneurship? The module's objective is to enable learners to recognize that utilizing entrepreneurship in all situations is a beneficial approach both on individual and societal levels.

• Module 3. Who Are Entrepreneurs? The module's objective is to enable learners to appreciate the personal characteristics needed to be a successful entrepreneur.

Module 4. How Do I Become An Entrepreneur? The module's objective is to provide an understanding of the key competencies and determining factors for success in entrepreneurship and small business management.

• Module 5. How Do I Find A Good Business Idea? The module's objective is to provide techniques for generating business ideas as well as for identifying and assessing business opportunities.

 Module 6. How Do I Organize An Enterprise? The module's objective is to enable learners to appreciate the procedures required for organizing an enterprise.

 Module 7. How Do I Operate An Enterprise? The module's objective is to enable learners to appreciate the various techniques that will affect the management of an enterprise.

Module 8. What Are The Next Steps To Becoming An Entrepreneur? The module's objective is to enable learners to pursue plans to start an enterprise.

Module 9. How Can You Elaborate A Business Plan? The module's objective is to enable learners to apply KAB knowledge to a real market situation and to evaluate a business idea.



There are several levels of KAB, from simple to complicated, whereby the variables change just like in real life. Students have to keep track of financial records, plan and operate against a deadline and work on marketing their ideas.

# History of KAB

t the end of the 1980s and the beginning of the 1990s, the ILO implemented several projects in Kenya's small and medium enterprise development and vocational education sectors. These ILO projects involved a number of government institutions and private institutions such as the Federation of Kenyan Enterprises (FKE). Though there was a keen demand for entrepreneurship education in Kenya, no specific training programmes were then available.

To close this gap, funds were provided in 1996 from the ILO Geneva and the ILO International Training Centre (ITCILO) in Turin to develop an entrepreneurship education programme for institutions of Technical and Vocational Education and Training (TVET). A workshop was organised in Turin with the participation of Dr. G. Manu from ITCILO, Mr. J. Thiongo, a Kenyan consultant and Prof. R. Nelson from the University of Illinois, USA to

develop the KAB training materials for trainers and instructors of TVET institutions. The materials were then field tested in Kenya, finalized and printed.

Entrepreneurship education that was inspired by KAB and Improve Your Business (IYB)" became part of the national curricula for vocational training in Kenya.

In the following years, ITC Turin organized several training workshops for participants from the vocational training sector, including instructors and international consultants from various countries.

KAB was translated into French by ITCILO and integrated as one activity in the "Gérez mieux votre entreprise"

(GERME) project (=SIYB West Africa, first phase 1999 to 2002). A KAB Training of Teachers course was organised in Turin in 2000 with participants from North and West Africa, including project staff from the GERME project. A test course was organized for adult women under skills

training in Senegal.

In 2000, KAB and SIYB were introduced in Kazakhstan through a Luxembourg-funded project: The KAB training package was translated into Russian; after a training of teachers and instructors, it was pilot tested in five vocational training schools. In May 2003, the curriculum development institution of Kazakhstan validated the KAB materials. A decree was subsequently issued introducing entrepreneurship education based on KAB in TVET institutions.

In 2002, KAB was adapted and translated into Spanish, Conozca de Entrepresa (CODE) and used in Bolivia. By an agreement with the Ministry of Education of Bolivia, CODE has been incorporated into the regional curriculum in the Chapare region.

In May 2004, the ILO Small Enterprise Programme (SEED) and the ITCILO Enterprise Development programme updated the KAB materials by organizing a workshop with the origi-

nal authors of the training materials assisted by Mr. Klaus Haftendorn and Mr. Peter Tomlinson as KAB editors. A new edition of KAB was published in 2005, and this is currently the main version in use around the world.

To respond to the increasing demand for KAB from ILO constituents, a KAB promotion and coordination unit has been established within SEED at ILO headquarters in Geneva. The first KAB global coordinator was Mr. Klaus Haftendorn, who was appointed in late 2007 to the position of Chief Technical Advise for an ILO youth entrepreneurship project for Norh Africa. The current Global KAB Coordinator is Mr. Nabeel Goheer, who continues to work closely with his predecessor.

Mr Klaus Haftendorn and Professor Robert Nelson revised the KAB materials during 2007, and an updated new edition of KAB was published by the International Training Centre of the ILO in February 2008.

# **Masked criminals**

short television episode about criminals being investigated recently drew my attention. Out of curiosity, I asked my

father the reason these criminals veiled their faces. They appeared to me like our veiled women, except that they were criminals while our women are guilty of simply being born that way.

Our society looks down on women as inferior, believing they should cover their faces so they won't be identified by or exposed to men A man on a bus of told me that the veil is like a guard that secures a woman's dignity, respect and

To the contrary, soldier Ahmed Al-Amari says, "The veil is a type of witchcraft attracting men's attention because we try to discover the hidden face behind the veil." Yemeni women are jailed like criminals. Just as a criminal's freedom is limited to his jail cell, their freedom doesn't extend beyond their black veils. It's a way to lock them up and keep them out of mind.

Ahmed Al-Hamadi, a teacher at Al-Amjad Private School in Sana'a, wonders how women can bear the imprisonment of such a mask, adding, "The veil is a cover for vice because women can do anything they wish without being discovered. Unveiled women may capture our first glance, but veiled ones capture our curiosity.'

A book isn't valued for its well-crafted cover but by its content. Likewise, the veil doesn't display signs of morality, esteem or respect, but rather signs of unfairness and lack of confidence. While shyness is natural, it is lack of self-confidence to be shy about expos-

According to Mona, a student at Sana'a University, a woman is a human being, not an object or a piece of meat; thus, she should be given the freedom to veil or not. She further notes that many women dream of being able to walk about unveiled, but Yemeni society enacts harsh barriers.

On the other hand, another student points out, "It's our tradition, so we should stick to it."

Yemeni women have the right to vote, drive and be educated. While veiling isn't a law in Yemen, society still considers it a compulsory necessity to be protected.

Islam does not oblige women to be veiled; rather, veiling was introduced into Yemeni society as a fashion by the Ottoman Empire, with high-class women wearing it.

However, veiling has prevailed throughout the entire scene of Yemeni society, changing from a fashion into a compulsory necessity.

Likewise, Salah Al-Shamiri affirms

that veiling has nothing to do with Islam, but says that traditions speak louder than religious teachings and instruction.

Veiling is a "compulsory option" in Yemen. While women aren't forced to veil, many choose to do so themselves. When they see all of their female family members wearing it, young girls seek to imitate their mothers, sisters and other relatives because they just want to be like them, even choosing different and elaborate types of veils.

As Asamae Al-Kholani says, "No one forced me to veil. I choose to wear it because all of the females in my family

For many tribal men in Yemen, luck has been the last resort when marrying. Taxi driver Najib from Arhab says he never saw his wife's face before the day of their marriage. Because his mother and sisters chose his wife for him, he didn't have the chance to even see the face of his future wife. "I'd seen her walking about, but she was always veiled."

Just as criminals have no right to choose their jail cell, Najib didn't have the right to see his wife or her appearance. It's unfair to force one to marry without even knowing how she looks. Enforcement doesn't equal necessity but rather, enslavement.

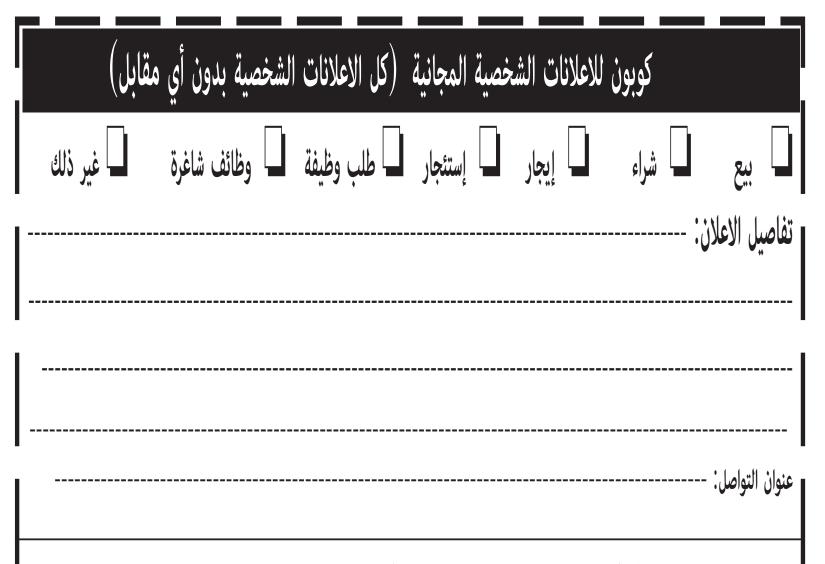

The Arab Thought Forum's Third Youth Conference:

# Toward developing institutionalized work for Arab youths

For two days, Arab youth from Morocco, Algeria, Tunisia, Libya, Egypt, Sudan, Somalia, Yemen, Oman, the United Arab Emirates, Bahrain, Kuwait, Saudi Arabia, Iraq, Lebanon, Jordan, Palestine and Syria came together to discuss various issues and what should be done to create a better future for themselves and future generations.

Sabreen is an 18-year-old Egyptian college student who has lived the past 10 years of her life in Jordan. Her Jordanian accent is so remarkable that one would be surprised to learn that she's originally from Egypt. Other than an identity issue, Sabreen complains of gender discrimination in her own fam-

"I wasn't allowed to travel to Syria to participate in an event that was so important to me and in which I was a key player. My family said they wouldn't allow their daughter to travel by herself to such an event. If it had been my brother who wanted to go, it would've been no problem. I hate that," she said.

Her frustration is one reason she began working at the college newspaper. She needed a place where she could express herself and where her work would be recognized because of her talent and not be objectified because of her gender or nationality.

Sabreen is just one of some 200 young men and women who participated in the Third Youth Conference organized by the Arab Thought Forum

in Amman the middle of last month. The forum takes an interest in young people as the future and this year's conference discussed ways to develop institutional work related to youth in the Arab world.

Jordan's Prince Hassan Bin Talal, who chairs the Arab Thought Forum, sympathized with Arab youth at the opening ceremony, describing their challenges and their not so encouraging environment. He pointed out that the situation of today's Arab youth is a direct result of what adults are doing. However, he highlighted ways to move ahead, indicating a ray of light through some of the activities and projects created by the forum and other concerned organizations.

"Like Martin Luther King, I too have a dream. I have a dream that one day our young men and women will rejoice at a life without discrimination, degradation and oppression," he said.

The prince emphasized the need to "empower youth legally because this is exactly what they need in order to find their place in the sun."

The forum's general secretary, Dr. Hassan Nafi'a, agreed, further noting that Arab societies suffer from oppression, corruption, high costs of living and lack of rule of law.

"Societies that take no interest in

women's and youth issues are rigid societies with no hope for development. The solution is to listen to the young generations and hold constructive dialogue with them," he proposed.

#### Nine themes, numerous recommen-

The participating youth were distributed among nine themes: education, family, health and environment, citizenship and public participation, religious influence, equality favoritism and nepotism, legal and legislative awareness, freedom of expression, networking and communication. Sessions took place over two days, concluding with numerous recommendations.

Among the general recommendations were to provide more training and public opportunities for youth so that they will learn more and gain more confidence in their abilities. Discussions focusing on technology revealed that Arab youth greatly depend upon the internet and modern technology.

Participants displayed concern about quality of education and lack of opportunities to participate, even at universities and higher education institutes.

As one University of Jordan student remarked at the education session, "We want teachers to respect us and work with us, not against us."

The young participants also pointed out that Arab families gradually are losing their close-knit structure and positive social values. They concluded that most family problems occur because there's no dialogue between family members and "nobody really wants to listen to the other," they com-

An interesting issue running throughout the sessions was the comparison between men's and women's rights and obligations. As expected, the men disagreed with the women on gender-related issues, but eventually agreed that for the sake of a better future for Arab youth, both men and women must be empowered.

#### Disparity and taboos

The youth participating in the sessions surprised the organizers and session leaders with their intellect and their deep understanding and concern.

Through her participation on the health and environment team, Samar Mazghani explained that certain taboos should be broken and youth should feel free to talk about certain currently frowned upon issues. For example, one's sexuality, political affiliation, religion, etc., shouldn't be hidden, but rather discussed openly so that both individuals and society as a whole may

Mazghani gave the example that drugs, AIDS and other STDs are spreading because Arab society refuses to acknowledge their existence or why they are occurring.

At the same session, the youths expressed their concern about the environment and how they should promote a sense of volunteerism among youth and children to care for their environ-

Heated discussions also took place regarding religion and religious influence in daily life. As Doa'a, a student at Jordan's Irbid University, commented, "I'm scared that the number of

fanatics is growing. I'm afraid that a day will come when the rights I've earned regarding education, work and public participation will be taken from me on the pretext of religion.

The youths also said they hope to emigrate from their respective countries because they find no freedoms or an encouraging environment in the Arab world in which to thrive and

"Let's face it, we aren't equal. There will always be someone who has a better opportunity than me because he or she knows some VIP or has more money or a strong family name," said one Iraqi student in Jordan.

Huda Al-Zu'obi, director of the Arab Culture Association in Gothenburg, Sweden, noted that she has seen many Arabs excel abroad and how they would rather live away from their homes and enjoy freedoms than live in oppressive countries surrounded by their family and friends.

She added, "It's a shame that we don't live up to our principles because there's so much to learn from Islam that could make us world pioneers.'

Heated discussions also took place on the freedom of expression team, with the participants split between those wanting no limits at all and those saying there must be rules.

"Let the people be the judge, not the Ministry of Information or any media council governed by the government. The people are the ultimate judges who will make a particular media either successful or not worthy of their time," Egyptian blogger Wael Abbas pointed

However, his idea wasn't well received because most of the young participants couldn't imagine a world without any boundaries. "It would be chaotic, and blasphemy and insult would spread," said Abdullah, a student at Jordan's Al-Esra University.

Time to listen, cooperate and create At the conference's final session, Prince Hassan briefly commented on what he saw and heard in the sessions.

"I'm delighted that I witnessed a sense of noble partnership and a true desire to listen and comprehend. But I also saw signs of creativity, pioneering and leadership and this has made me glad. I can say that this event was a great success," he concluded.

Commenting on some of the youths' remarks in the nine sessions, he indicated that they should be turned into real projects to be seen and felt in practical life. However, he also emphasized the need for legal education and aware-

The prince noted that if there's a sin-

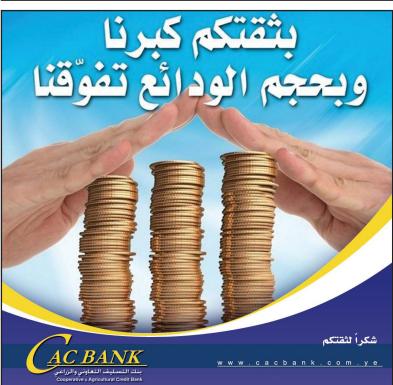
gle project deserving the Arab world's attention and support, it's creating career development centers for youth. He explained that through such centers, young men and women in the Arab world can become empowered with the skills and capacities required in the job market rather than wasting years studying redundant topics or becoming depressed due to unemploy-

Finally, Prince Hassan congratulated the participants for their efforts, noting how they came from around the Arab world and farther to listen to each other and cooperate in order to create seeds for projects and ideas that will make Arab youths' future brighter and more prosperous
